SCOPE OF SERVICES

II. DESCRIPTION OF SERVICES

- A. CONTRACTOR shall provide pro-social programming and Multi-Disciplinary Team services to residents of the Sacramento County Youth Detention Facility, designed to help at-risk youth successfully transition from an in-custody setting back into the community.
- B. The following programs and services shall be included in this Agreement:

1. <u>Capacity Changers/Alternatives to Violence Programming</u>

The Capacity Changers/Alternatives to Violence Programming is a pro-social curriculum focused on different ways of resolving conflict, developing life skills, and making better choices in the future, and includes the following workshops/trainings.

a. The Barbershop Encounter

Facing Giants

The aim is to identify common ground between youth while liberating them from the convenience and safety of a fixed mindset.

Moving Forward

To identify where one is currently and presently. This lesson provides participants a gentle PUSH to where they desire to be or DREAM to be. It provides a mark to reach towards.

The Menu

Use key terms related to violence and victimization to foster discussion that will enhance awareness and

acknowledgement of personal contribution to violence or violence prevention.

Conflict Resolution I

To identify how one currently handles conflict and examine alternative ways of handling conflict in better and more appropriate ways.

Conflict Resolution II

Learn how conflict styles matter and that style is versatile and a choice.

o The Push

Participants will have the opportunity to map/draw out a personal resolution using a personal goal setting poster with identified roadblock solutions.

b. The Adjustment Encounter

The Adjustment Encounter is designed for residents that need to build more intensive skills regarding thought patterns, stress, complicated relationships, grief, and many other common life challenges. We intentionally and strategically integrate YDF's Culture Card Daily Principles into each lesson based on the individual adjustment need of the residents present for the encounter. This Adjustment Encounter is very fruitful in promoting growth and change by encouraging youth to make better decisions in the future by resolving issues in a positive and Prosocial manner.

c. Acme Moment Encounter

The Acme Moment Encounter is designed to function in YDF's Orientation Unit where new residents (within the first seven days) await a court date or a housing assignment. The Acme Moment Encounter highlights and helps residents see in this defining moment in time, a reflection of themselves and questions like; "what are you going to do about what you see?" Encouraging participants to self-reflect and Answer questions in the Acme Moment, is the Encounter we inspire.

d. The 24-Hour Prosocial Encounter

The 24-Hour Prosocial Encounter is a training designed for current high security residents. This encounter provides redemption, and a second chance to prove merit by demonstrating remorse and restoration to health or normal life. Participants are given an outlet to restore their health and increase their capacity for positive outcomes through

Prosocial training. Trained residents (completers of the encounter training) will have the opportunity to "pay it forward" by sharing their personal story in an "unfollow me" way.

e. Pathways to Success Encounter

This encounter utilizes CCP partnering subcontractors to assist in addressing the assessed needs of residents in the Youth Detention Facility and Valley Oak Youth Academy (VOYA) programs.

2. Parenting Encounter

The Parenting Encounter is a training designed for parents or expecting parents targeted at improving the parent-child relationship in hopes to enhance the quality of interactions, foster secure attachments, and maintain strong bonds during the period of incarceration. Ultimately this intervention will improve developmental outcomes for the child and the teen parent. It is a 12 week program with one 2 hour session per week. The Parenting Encounter also includes Family Reunification, an intervention targeting interaction between parent and child. This will include a parenting training program and structured visitations. The aim is to improve Parent-Child interaction durina incarceration empowering parents to develop a relationship with their children active play, engagement. and social/emotional development. Parenting Encounter referrals shall be made by Court order only. Special exceptions may be included upon approval from the YDF Chief Deputy (to be included in the billing).

3. Multi-Disciplinary Team (MDT) Services:

Upon mutual agreement between COUNTY and CONTRACTOR, CONTRACTOR shall participate as a member of a Multi-Disciplinary Team. MDTs are designed to provide a holistic approach to client's complex care needs and may consist of (but not limited to) youth and their families, school representatives, probation officers, mental health counselors, and other law enforcement staff. CONTRACTOR's participation in MDT includes:

- a. Attending MDT meetings organized by COUNTY as needed
- b. Providing input and assistance regarding program delivery to ensure program efficacy
- ·c. Providing input and assistance regarding transition/re-entry support services in the community as deemed appropriate

d. Provide youth linkage to re-entry support services upon release from YDF by providing program and contact information based on youth's needs and locality

4. <u>Individual Services</u>

Upon mutual agreement between COUNTY and CONTRACTOR, CONTRACTOR shall meet with YDF youth on an individual basis to provide individualized lessons, mentoring, and consultation sessions.

- C. COUNTY and CONTRACTOR shall develop and implement data collection documentation and procedures to adequately track the program processes and outcomes in order to determine program efficacy.
- D. COUNTY and CONTRACTOR shall meet as needed to discuss the goals and objectives of this Agreement, and shall also meet as necessary to address any issues with the day to day operations.
