ACTION ITEM: JJCPA-YOBG Expenditure Report Review and vote	15 Minutes	Marlon Yarber, Chair

The Chair referenced a question on the report from the last meeting by Designee member Burg regarding housing and the funding stream. The Chair asked for clarification from Dawn Isais. Isais stated the juvenile field supervision section of the plan, specified that Probation provides transition age youth food and emergency housing. People Working Together and Exodus, provides three-day hotel vouchers for emergency housing. Another section in question, referenced under our Roadmap to Success Strategy utilizing JJCPA funds. Probation uses Stanford for our juvenile justice intervention services. The last section in question was regarding juvenile sex offenders. Probation uses Hope for Healthy Families which is indicated in the narrative of that section.

The Chair reminded the committee that this is a report of what has already occurred and been expended. We will be coming back with a plan for the coming year, likely in April to show how these funds are utilized going forward. The Chair stated regarding our subcommittee, we have an RFP in process relative to transitional housing for our realignment population. The hope is that a provider will come forward and offer to staff a house 24/7 with four to six beds to help address our needs with that population.

Member White asked, in section four, accounting of expenditures for juvenile hall, the funds are listed under administrative overhead versus salaries and benefits and sought clarification as to why it was listed in that section. Dawn Isais stated that it is not a staff cost, it's an administrative overhead for the building. The Chair stated that the Couty Executives Office is encouraging us to move some of these funds inside to YDF to support expenditures there.
