<p>The Chair welcomed the committee and guests. The Chair gave an update on budget. There won't be much growth other than legal requirements, mandates or new legislation. Other jurisdictions have had hiring freezes or reductions, but currently we are not facing those actions. The next budget year 2025-26 may be more challenging.</p> <p>The Chair also shared that Pine Grove numbers have been low, and it has been proposed to combine the secure track population with the state's youthful offender adult population managed by CDCR. Chair reached out to Member John Grimes and Co-chair Reuben Moreno on potential interest in touring the current program. Chair mentioned that Growlersburg Conservation Camp would arrange a visit for us and a presentation on the program they run. More information will come on the status of Pine Grove.</p>

<p>Chair discussed the new challenge was to update the Plan for 2024-25 on programs that have been already implemented versus programs still in the planning stage. Chair highlighted programs implemented and how the challenge remains addressing the number of secure track youth as we have exceeded projections. Probation works to find alternatives, not just solely look towards Pine Grove. JJCC Subcommittee guest, Dawn Isais briefly went over the changes on the JJRBG Plan since the last meeting. She asked the Committee if they had any more revisions.</p> <ul style="list-style-type: none"> ○ Committee members Jacqueling White, Sarah Davis, Raechel Ibarra, Richard Matulia, Jenny Ng, Shanelle Patterson and Co-chair Reuben Moreno communicated their revisions. ○ Funding for the Community Advocate position versus transitional housing <ul style="list-style-type: none"> ➢ The Chair reminded the committee that once we get the funds, we will have a better sense of where we can allocate those funds. ➢ Chair also mentioned the OYCR \$2 million grant for housing 10 youth each year over a 2-year period. <p>Motion: To accept the new language suggested on the last 2 paragraphs of page 32.
