Chief Probation Officers of California Annual Statewide Conference

Sacramento County Probation Chiefs, Supervisors, Probation Officers, and Administrative Professionals proudly represented the department at the statewide Annual Chief Probation Officers of California (CPOC) Conference, which took place October 22 - October 24, 2025. This year's theme, "Invest in People, Invest in Safety," featured inspiring keynotes, agency collaborations, and important conversations about the future of probation.

Senior DPO's Erin Burton and Patrice Pratt, along with Sacramento Sheriff Deputy Officer Chansavang Oriyavong, presented "The Power in Partnership: Advancing Probation Outreach Through Collaboration." They shared success stories and insights from working with multidisciplinary teams to address homelessness, earning praise from attendees for their dedication and impact.

The conference provided an invaluable opportunity for Sacramento County Probation to share best practices, strengthen partnerships, and continue advancing innovative strategies that enhance public safety and community well-being.







2025 T.H.R.I.V.E. Summit

Probation Participates in 2025 T.H.R.I.V.E. Summit & Community Engagement Mixer



On October 15, 2025, several Sacramento County Probation staff members proudly participated in the T.H.R.I.V.E. Summit & Community Engagement Mixer, a countywide event aimed at fostering community connections, hosted by Sacramento State University.

The summit, organized by the Office of Diversity, Equity and Inclusion, brought together County departments, community organizations, and members of the public to explore strategies for fostering equity, collaboration, and inclusive service. The T.H.R.I.V.E. principles Transparency, Healing, Renewal, Inclusion, Voice, and Empowerment, served as the foundation for the day's programming.

Chief Probation Officer Jamal Rowe was invited as a guest speaker, providing insights into the intersection of public safety with community-driven change and transparency. Shelly Cortez, Administrative Services Officer II, collaborated with Cephoni Jackson, Sacramento County's Chief Diversity, Equity & Inclusion Officer, and the program committee to create and facilitate the summit program, agenda, and branding. Several Probation officers and staff were in attendance, demonstrating our department's commitment to engaging with broader County initiatives and advancing inclusive, community-informed practices. The afternoon mixer provided a unique opportunity to connect with other departments, local organizations, and community advocates. All participants were united by the shared goal of building a more responsive and equitable Sacramento.







Multi-Jurisdiction Collaboration

Countywide SAFE Team Operation

On Halloween night, Sacramento County Probation Officers and Sheriff's Detectives assigned to the SAFE Team partnered with Parole Services for a countywide compliance operation. The goal was to ensure registered sex offenders were following the terms of their probation and parole.

During the operation, officers contacted 28 individuals, resulting in 11 arrests for probation and parole violations. In addition, four individuals were arrested on new charges, including:

- Felon in possession of a firearm (PC 29800(a)(1))
- Failure to register a concurrent address as a sex offender (PC 290.010)
- Possession of child pornography (PC 311.11(a))
- Possession of a controlled substance (H&S 11377(a))

This collaborative effort underscores the ongoing commitment of Probation, Parole, and the Sheriff's Office to enhance community safety and ensure accountability among supervised offenders.





Unit Spotlight

Family Violence Unit Recognized for Outstanding Service

On October 2, 2025, the Family Violence Unit and Deputy Probation Officer Aracely Hurtado received the Symbol of Service Award from the Domestic Violence Prevention Collaboration. This award honors their dedication and compassion in supporting survivors of domestic violence in Sacramento, as well as their extraordinary efforts to help end the cycle of violence.

The Sacramento Domestic Violence Prevention Collaboration is a multi-agency initiative focused on preventing domestic violence through advocacy, education, intervention, law enforcement, and coordination of resources.

The recognition underscores the team's commitment to providing safety, support, and resources to families affected by domestic violence. Their collaborative work with community partners continues to make a meaningful difference in the lives of survivors throughout Sacramento County.





Unit Spotlight

Family Violence Compliance Sweep

On October 22, 2025, in recognition of National Domestic Violence Awareness Month, the Sacramento County Probation Department's Family Violence Unit conducted a county-wide probation compliance sweep. The operation was carried out in partnership with the Sacramento Police Department (Family Abuse Unit), Sacramento Sheriff's Office (North POP Unit), Galt Police Department, Rancho Cordova Police Department, Folsom Police Department, Elk Grove Police Department, and the California Department of Corrections and Rehabilitation K-9 Unit.

The sweep focused on contacting clients on probation for domestic violence-related offenses to ensure compliance with court-ordered conditions. Officers also conducted searches, served warrants, and arrested individuals in violation of probation terms. Victims were provided access to resources through the Sacramento Regional Family Justice Center. Evidence seized included approximately 460 rounds of 9mm ammunition, firearm magazines, and controlled substances including fentanyl, heroin, and methamphetamine.

Sweep Results:

- 67 clients contacted
- 89 searches conducted
- 26 probation violations filed
- 15 arrests made
- 2 citations issued
- Controlled substances and firearms seized

On Friday, October 10, 2025, Sr. DPO Heather Fristoe and K9 Ace competed against 13 teams in the Western States Police Canine Association (WSPCA) trial hosted by the Lodi Police Department and had an incredible day of results!

- 1st Place Overall Firearms
- 1st Place Vehicle Firearm Search
- 5th Place Building Firearm Search
- 3rd Place Building Narcotics Search
- 4th Place Overall Narcotics

This was their third trial of the year, and their outstanding performance helped them finish the competition season ranked 3rd Overall for the Year in Detection with WSPCA.

K9 teams earn points throughout the year at each WSPCA trial, which contribute to year-end rankings. At the end of the season, WSPCA recognizes the Top 10 K9 Teams based on total points accumulated across all competitions.

"I'm incredibly proud of Ace's work, focus, and drive," said Sr. DPO Fristoe. "Every competition is a chance to learn and grow together, and I'm thankful for the opportunity to represent our department."







Sacramento City College Hosts Fall 2025 Speaker Series

On October 16, 2025, officers from the Mental Health and Collaborative Courts Units took the Probation Outreach Vehicle to El Hogar Community Services to meet with clients. 

On October 1, 2025, probation officers conducted surveillance related to an ongoing investigation. During the operation, the subject was observed and believed to be armed. To ensure community safety, law enforcement assistance was requested. The subject attempted to leave the area but was safely detained following a coordinated response. A loaded, un-serialized firearm and presumptive amount of cocaine was recovered during a subsequent vehicle search.

On October 14, 2025, probation officers conducted a home visit as part of an ongoing supervision case. During the contact, officers observed items of concern and conducted a compliance search. Multiple firearms, a large quantity of ammunition, and an un-serialized firearm component were located. The individual was taken into custody for related violations.

During a probation contact of an individual placed on formal searchable probation following a felony conviction, officers discovered inappropriate material on the individual's electronic devices. The individual was taken into custody, and the devices were seized for forensic analysis, which confirmed a large volume of illegal content. On October 17, 2025 the individual was subsequently add booked, for additional felony violations and sentenced to state prison for 2 years after pleading guilty.

While conducting field supervision near Florin Road and 25th Street, officers contacted an individual on active probation. During a probation search, officers located a loaded firearm, approximately 15 grams of suspected methamphetamine, and \$200 in cash. The individual was arrested and booked into the Sacramento Main Jail on a probation violation and pending firearm and narcotics-related charges.
