Black Child Legacy Campaign Annual Report

On Tuesday, November 4, 2025, Sacramento County Probation Department leadership, including Chief Rowe, Chief Deputy Marietti, Assistant Chief Deputy Linden, and members of the Black Child Legacy Unit, attended the Annual Report on the Black Child Legacy Campaign (BCLC) at the Board of Supervisors. The report, presented by Chief Rowe, Supervising Probation Officer Estrada, Senior Deputy Probation Officer Wilbon, and BCLC Community Partners, highlighted the campaign's accomplishments within Sacramento and its influence beyond county lines.

Initiated in 2013 by the Steering Committee focused on the Reduction of African American Child Deaths, BCLC was created in response to concerning statistics indicating that Black/African American children were dying at double the rate of children from any other racial or ethnic group. Since 2015, the Board of Supervisors has allocated funds to assist BCLC in fulfilling its mission in Sacramento.

The campaign's success reflects a collaborative effort among the Steering Committee, Sacramento County Social Services, and Probation, guided by a public health approach and strengthened by community engagement. Client testimony and data collected to date underscore the positive impact of BCLC and highlight the ongoing need to sustain this critical initiative in the years ahead.

Beyond the Bench Conference



On November 18 and 19, staff from the Sacramento County Probation Department participated in the Beyond the Bench conference, a statewide multidisciplinary event centered on children, youth, and families within the California court system. Initially launched in 1988, this conference attracts more than 1,200 professionals and made its return this year after a pause since 2019.

The sessions addressed important legal subjects related to juvenile dependency and delinquency cases, along with crossover issues including domestic violence, tribal-state court jurisdiction, mental health, and trauma-informed practices.

Sr. DPO Abigail Castro Inspires Young Men on the Dangers of Drunk Driving



Sr. DPO Castro recently had the opportunity to speak to participants of the Young Men Service League (YMSL), Roseville Chapter, a mother-and-son volunteer organization for young men ages 15–18. The YMSL provides its members with monthly motivational speakers who address topics relevant to their age group and community involvement.

During the session, Sr. DPO Castro shared insights from her work in the Office of Traffic Safety/Driving Under the Influence Unit, highlighting the risks and consequences of drunk driving. She emphasized the importance of making safe and informed choices, providing guidance that these young men might not often hear until it's too late.

This engagement offered a unique chance to positively influence teens before poor decisions are made, showcasing how community partnerships can make a real difference. The young men left with a deeper understanding of the impact of their choices and the role of probation in promoting public safety.

<u>Probation Staff Attend Health and Wellness Training for First Responders</u>

Seven members of our Department recently participated in the Health and Wellness Training for First Responders, hosted by 1st Responders Conferences. This two-day event brought together professionals from across public safety to focus on strategies that promote resilience, reduce stress, and support overall well-being in high-impact professions.

Throughout the conference, attendees engaged in sessions covering emotional health, physical wellness, peer support, and practical tools for maintaining balance in a demanding work environment. Presenters shared evidence-based approaches to managing chronic stress, identifying early signs of burnout, and building healthy coping strategies.

Our staff returned with valuable insights and resources that will not only enhance their personal wellness but also strengthen their ability to support colleagues and the community we serve. Peer Support looks forward to integrating these tools into ongoing wellness efforts within the department.

On November 6, 2025, a strong-arm robbery occurred at Consumnes Oaks High School resulting in the theft of a gold chain. Probation Officers located a suspect who was on ankle monitor, and Elk Grove Police Department Special Investigation Unit assisted in locating a group matching the suspects' description in a nearby parking lot. Nine individuals were arrested, stolen property was recovered, and a 9mm un-serialized handgun was seized. The same group was linked to an additional robbery at Monterey Trails High School, with six of the nine under Juvenile Probation. A follow-up probation search on 11/7/25 at a person on probation's residence led to the recovery of a Charles Daly PAK 9mm firearm.

Gang Intelligence Unit Juvenile Field

Sacramento County

From November 5th-7th, Officers from Adult Service's Gang Intelligence Unit and Juvenile Service's Community Based Supervision Units, along with the assistance of K-9's Duke and Ace, participated in the Sacramento County Sheriff's Office Gang Suppression Unit's Operation Streetsweeper, a coordinated multi-agency enforcement effort targeting gang-related violence and crime.

Over the course of the three days, Officers contacted nine known gang members/associates and made seven arrests. Of those arrests, three suspects were arrested for fresh crimes, and five violations of Probations were petitioned to the courts and one Flash Incarceration submitted.

Through various Probation searches, officers recovered two firearms, various rounds of ammunition, over 120 grams of cocaine, five bottles of counterfeit prescription bottles and over \$1,400 in was seized.

With guidance from the SCOE Landscape Instructor, Mr. Wilson, they built a compost bin to support future projects. Residents are not only growing their knowledge but also demonstrating leadership by mentoring one another.

California Special Election

Residents at the Youth Detention Facility participated in California's 2025 Special Election. Before voting, were provided with election materials to help make informed decisions. Programming staff set up a private voting area to ensure ballots were cast confidentially. This initiative was designed to foster civic engagement, ignite interest in the voting process, and motivate residents to remain active in elections even after their time at the facility.
