Multi-Jurisdiction Collaboration

DUI/OTS Unit Collaborates with Local Law Enforcement to Promote Roadway Safety

In continued efforts to promote public safety and reduce impaired driving, Sacramento County Probation Department's DUI/ Office of Traffic Safety Unit (OTS) partnered with two local law enforcement agencies in back-to-back DUI/CDL checkpoint operations.

On June 20, 2025, Sr. Deputy Probation Officers (Sr. DPO) Abigail Castro and Miguel Lopez, along with Supervising Probation Officer (SPO) Marcel Bonardd, supported the Elk Grove Police Department (EGPD) in a checkpoint operation held in the City of Elk Grove. Probation officers assisted by conducting field interviews, evaluating drivers for signs of impairment, and verifying driver license statuses.

Just one week later, on **June 27**, **2025**, Sr. DPO's Miguel Lopez and Jose Ramirez, along with SPO Marcel Bonardd, participated in another checkpoint operation—this time in partnership with the **Sacramento Police Department (SPD)**. Similar duties were carried out by the probation team, helping ensure the safe screening of hundreds of drivers.

These operations marked the **third and fourth checkpoints** conducted by the DUI/OTS Unit during the current Office of Traffic Safety grant cycle. They underscore our department's ongoing commitment to supporting local agencies, promoting responsible driving, and keeping our roadways safe.

SACCATS Investigation Leads to Recovery of High-End Stolen Vehicles

On June 10, 2025, Sr. DPO Jacob Bandilla assigned to the Sacramento County Auto Theft Suppression Team (SACCATS) received a tip from Sheriff's Dispatch regarding an online listing for a stolen 2018 McLaren. The vehicle was reportedly located at a residence in South Sacramento.

Sr. DPO Bandilla conducted surveillance of the residence and determined a search warrant would be necessary to recover the vehicle. Upon serving the warrant, officers located the stolen McLaren inside the garage. In addition, a VIN-switched Mercedes G63 AMG was discovered in the backyard.

Just days later, further investigation led to the recovery of a third vehicle a stolen Lexus LX 700h SUV.

The combined estimated value of the recovered vehicles is approximately \$600,000. The investigation remains ongoing.

On June 5, 2025, Sacramento County Probation Officers conducted a home visit on an individual under Formal Searchable Probation.

A probation search of the residence revealed an un-serialized 9mm semi-automatic handgun with a black frame and silver slide, commonly referred to as a "ghost gun." Under Miranda advisement, the primary subject admitted to possessing the firearm and stated they had purchased it in the Bay Area. They were arrested for PC 29810(c) and booked into the Sacramento County Main Jail.



On June 5, 2025, Probation received information reporting an individual on probation was not residing at their registered address but was staying in a trailer located in the backyard of an unreported residence. The individual was scheduled to report to the Probation Office that day.

Officers observed him leaving the unreported residence prior to arriving at the Probation Office. Upon arrival, they were detained and interviewed, during which they admitted to living in the trailer and provided keys to the unit.

A probation search was then conducted at the trailer location. The search uncovered approximately 181 rounds of ammunition, 49 grams of methamphetamine, 12 grams of fentanyl, a functional digital scale, and sandwich baggies consistent with drug packaging.

They were arrested on multiple charges, including violations of Penal Code 30305, and Health and Safety Codes 11378, 11377, and 11395(b)(1) and booked at the Sacramento County Main Jail.

On June 17, 2025, a PRCS client reported for their scheduled probation appointment. Although they initially denied driving to the location, officers located his vehicle parked nearby.

The client was detained, and a probation search of his person produced keys to the vehicle. A subsequent search of the vehicle led to the discovery of a stolen .40 caliber Glock 22 handgun, four Glock magazines, live ammunition, a canister of bear spray, 18 grams of suspected crystal methamphetamine, a digital scale, and narcotics paraphernalia.

They were arrested and booked into the Main Jail on a violation of PC 3454(c) and is pending additional charges including HS 11370.1, 11377, 11364 and PC 29800(a)(1), 30305(a)(1), 22810, and 496.

On June 5, 2025, Probation Officers conducted a compliance search at the residence of a known probationer prohibited from possessing firearms after receiving information from an anonymous source indicating the individual may be in possession of weapons.

The search resulted in the seizure of two rifles, various firearm components, numerous magazines, including a high-capacity drum magazine, and over 130 rounds of ammunition.

During an investigation involving a probationer, a Deputy Probation Officer developed information regarding an individual in possession of an unregistered firearm, a U.S. Postal Service master key, and identity theft materials.

The subject, currently on Pre-Trial GPS monitoring with pending charges including false identification to a peace officer, check fraud, and two counts of grand theft, also has an active Informal Probation grant for grand theft.

Deputy Probation Officers, in coordination with the Sacramento County Sheriff's North POP Team, tracked the individual to West Sacramento. A traffic stop was conducted, resulting in the recovery of a loaded 9mm handgun, the USPS master key, and various identity theft-related items.

The subject was arrested and booked into Yolo County Jail on firearms-related charges. Additional charges are pending as the investigation continues.

On June 11, 2025, North POP Team officers conducted a compliance check on a subject under Formal Searchable Probation. During a probation search of the living room, where the subject resides and stores personal belongings, officers located a safe containing an unserialized P80 firearm, a high-capacity magazine, and ammunition.

The subject, a convicted felon prohibited from possessing firearms and ammunition, was arrested and booked into the Sacramento County Main Jail for the following charges:

- PC 29800 Felon in Possession of a Firearm
- PC 30305 Felon in Possession of Ammunition
- PC 32310 Possession of a High-Capacity Magazine

A supervised individual currently on PRCS was involved in a vehicle stop conducted by the Sacramento County Sheriff's Office on May 20, 2025. The individual was identified as the driver, and the vehicle was impounded due to an ongoing investigation in a neighboring jurisdiction.

Follow-up by Probation Officers led to a search of the impounded vehicle. During the search, officers discovered a loaded .40 caliber Smith & Wesson handgun concealed behind a panel in the trunk. The firearm was reported stolen out of Houston, Texas.

The individual, who is currently in custody, was additionally booked on several charges related to the investigation, including PC 29800(a)(1), PC 25850(c)(2), PC 30305(a)(1), and PC 32310.

Sacramento County Probation's Youth Detention Facility Receives Full NCCHC Accreditation

The Sacramento County Probation Department Youth Detention Facility has achieved 100% compliance with all applicable essential standards outlined by the National Commission on Correctional Health Care (NCCHC).

Following the NCCHC's onsite review conducted November 20–21, 2024, and the Provisional Accreditation granted on February 14, 2025, the facility was officially awarded full accreditation. All 36 applicable essential standards have been met, marking a significant milestone in our continued commitment to high-quality care and operational excellence.

The NCCHC standards are designed to enhance health outcomes for justice-involved youth, ensure the effective delivery of care, and reduce clinical and legal risks within correctional facilities.

This accomplishment is a reflection of the hard work and dedication of our staff and health care partners. They remain committed to supporting the well-being of the youth entrusted to our care and upholding national best practices.





Youth Detention Facility Staff Appreciation

The Youth Detention Facility had a busy month filled with a variety of activities. A highlight was Staff Appreciation, during which YDF Administration provided meals during each unit meeting. The gesture boosted morale and energy, leaving staff feeling recharged and grateful for the administration's recognition.







Northern California Construction Training (NCCT)

This month in the NCCT program, students demonstrated outstanding growth, discipline, and hands-on trade skills through a dynamic mix of physical challenges and construction projects.

Students kicked off June by completing *Patriotic Flag* builds in anticipation of the 4th of July. This creative project encouraged teamwork, attention to detail, and pride in craftsmanship, resulting in vibrant, meaningful displays that reflect both individual effort and collective spirit.


A major highlight of the month was the *quarterly Laborer's Agility Test*, where students pushed themselves physically and mentally to meet real world labor standards. Their determination and effort were impressive, and we're proud to announce the new "Top 8," a recognition given to those who excelled in strength, endurance, and agility. This distinction celebrates hard work and sets a high bar of excellence for the rest of the cohort.

Most recently, students applied their technical skills in a hands on *Campfire Stool* build. Using cut sheets and assembly diagrams, they measured, cut, and assembled stools using chop saws, tape measures, and a variety of hand and power tools. This project reinforced their understanding of construction fundamentals while also building confidence in tool use, precision, and following technical plans.

June has been a powerful month of learning, growth, and achievement. These students are not only gaining valuable trade skills, they're developing the mindset, work ethic, and resilience needed for long-term success.









Culinary Arts Program

For the month of June, Culinary began their Summer Cohort on June 10th. During the first week, Chef Doolittle discussed the syllabus and classroom expectations during the morning session. In the afternoon, Chef Doolittle conducted a food and taste experiment using jellybeans. He had the students plug their noses and eat a jellybean. The students experienced the jellybean lacking flavor until they unplugged their nose and the taste of the jellybean became apparent. Chef Doolittle explained how we need oxygen and saliva working together for our taste buds and our brain to identify flavors on our tongues.

During week two, students rolled up their sleeves and got hands on with baking as they learned to make zucchini bread. Under Chef Doolittle's guidance, they practiced accurate measuring techniques using cups and spoons before following a step-by-step recipe to prepare and bake the bread from scratch.

During week three, the Tuesday, Wednesday and Friday students made French onion soup paired with freshly baked baguette slices. They focused on knife skills, sautéing, and oven baking techniques.

The Thursday advanced class tackled a more complex dish, shrimp gumbo. Students developed flavor-building skills through sautéing, simmering, and combining multiple ingredients to bring the hearty dish together.

June was an eventful month at the Youth Detention Facility. On June 16, 2025, two residents participated in a baptism ceremony. This meaningful occasion marks the beginning of a new chapter in their spiritual journey. It represents a significant step toward personal growth and lasting positive change that they will carry with them for years to come.

Sacramento Office of Education (SCOE)

On June 5, 2025, Probation, SCOE, and Lake Tahoe Community College staff and families were proud to celebrate and recognize the achievements of four high school graduates and one community college graduate who have successfully completed their academic journey.
