**Overview**

The State Fiscal Year 2011-12 Budget included the realigning of state-local programs that re-directs authority and responsibility to the local level, with associated funding. This realignment effort eliminated duplicative administration of services, limited overhead costs, and allowed for locally determined priorities while maintaining statewide goals and objectives. As part of the realignment plan, a Community Corrections Partnership (CCP) Executive Committee was formed to develop and recommend an annual local plan to the Board of Supervisors on how public safety realignment should be implemented within the County. One of the members of this committee needs to be the head of the county department of social services, mental health, or alcohol and substance abuse programs. Under the current county structure, these programs fall under Countywide Services. I am recommending that the Board appoint Paul Lake, Chief Deputy County Executive for Countywide Services, to the CCP Executive Committee.

**Recommendation**

Adopt the attached resolution designating Paul Lake, Chief Deputy County Executive, to the Community Corrections Partnership Executive Committee.

**BACKGROUND AND DISCUSSION**
