Staff presented the results of the survey and focus group efforts from the Outreach to Justice Involved Individuals and Families Ad Hoc Committee. Staff sought and the CCPAB provided input on how best to update the presentation to be shared with the Community Corrections Partnership at its June meeting. No public comment was received.

6. Discussion of Services/Programs for Potential Inclusion in AB 109 Plan 2023 Update and Development of Member Questionnaire

Staff described the need to refine the CCPAB's priorities for potential inclusion in the AB 109 Plan 2023 Update to ensure that it clearly identifies which expenditures are eligible and prioritized. While all programs and services are valuable to CCPAB members, without prioritization, it is difficult for the agencies and public to understand how the CCPAB desires for AB 109 funds to be spent. Staff shared the 20 prioritized services in the AB 109 Plan 2022 Update, offered an opportunity for the CCPAB to add additional programs and services not currently included in the plan, and shared that a questionnaire would be distributed to members. CCPAB members requested to add restorative justice programs and nutritious food in custody to the priority service list. Staff will distribute a questionnaire to members asking them to rank all the items in order to facilitate a discussion at the June CCPAB over areas where consensus can be found, and to drill down on those items prioritized by members to refine what services would be considered reimbursable through AB 109 funds and who can receive those funds. Costs for supervision and custodial housing/health services for AB 109 offenders are excluded from the ranking as they will be eligible services under the plan.

Public Comment:

A member of the public commented that they would like to see restorative justice programs added to the CCPAB's priorities, collaborative court and diversion courts separated within the prioritization list, and workload impacts separated by departments. The member of the public also encouraged the CCPAB to recognize upcoming changes to pretrial services and ask questions.

At our May meeting, someone remarked on how appreciative some clients have been when offered this or that assistance. Later on, I recalled my friendship with an OG, which began about 20 years ago. He was a lot like 'Bad Leroy Brown.' I realized that while he was appreciative of what he was offered, he never asked for anything. Why? Because when you are inside, asking for anything is dangerous. It's not safe to owe anything to anyone when you are incarcerated in the prison.

Sustainability Information

I share here some basic, big-picture, and philosophical information about our technological system, which system is all the infrastructure and processes that fossil fuel energy has made possible, and that we take very much for granted. I recommend NOT taking our current physical plant for granted. We need backup plans. Why?

Fossil energy is very cheap. It would take a healthy adult about 100 hours of continuous work (\$15/hour), such as on a bicycle generator, to generate the amount of energy available from a gallon of gas (\$5/gallon). There's a reason we're addicted. I believe that harvesting energy is the most basic biological instinct and wisdom bids us get a whole lot better at using it efficiently—and soon.

Because it's so cheap, we are wasting a lot of it, and much of that is just for empty profits. **Efficiency** is usually defined as the ratio of output to input. In the case of physical (fossil) energy, the key output we want are our physical needs: clean air and water, healthy food, cooking, comfy shelter, and plenty of sleep and exercise. And the input is simply - the earth.

We have been living beyond our ecological means for some time. In "Climate - A New Story," Charles Eisenstein critiques the standard priority of reducing emissions of greenhouse gases (GHG) from fossil fuel use. Rather, Eisenstein is convinced that the real threat of "climate derangement," at least as much as fossil fuel emissions, is what we have done with those fuels—"primarily the degradation of ecosystems worldwide: the draining of wetlands, the clear-cutting of forests, the tillage and erosion of soil, the decimation of fish, the destruction of habitats for development, the poisoning of air, soil, and water with chemicals, the damming of rivers, the extermination of predators, and so on. Through disruption of the carbon cycle, the water cycle, and more mysterious Gaian processes, these activities degrade the resilience of the ecosphere, leaving it unable to cope with the additional greenhouse gases emitted through human activity."

We cannot graft our fossil fuel lifestyles onto PVs, windmills and batteries. **Electrifying everything** is not a realistic solution; it just does not scale. Fossil fuels are required for the mining and refining needed to provide the metals and minerals to manufacture those nonrenewable harvesters of renewable energy. And all mining and all pavement reduce the carrying capacity of the planet.

The giant fusion reactor in the sky has powered the whole planet for several billion years. Fossil fuels have only been around for a few centuries. But ditching fossil fuel addiction will take a paradigm shift. Eisenstein describes many ways that natural ecological cycles have been disrupted. Reviving them *is* the paradigm shift. Biology is solar-powered, but machines are money-powered.

All enterprises will be confronted with turbulent economic and ecological conditions, inexorably, unevenly, and unpredictably. This includes the criminal justice system, and these conditions will affect everything from cop cars and electronics to building operations, food and utilities. Of course, **this is not relevant to next year's budget.** But budgets, and indeed the market system, are subject to nonhuman influences and various and accumulated fossil-fuel externalities.
