- **CCP Member – 1230(2)(L) Penal Code:**
 - [PC 1230](#) specifies: The local Community Corrections Partnership shall be chaired by the Chief Probation Officer and comprised of the following membership:
 - (L) A representative from a community-based organization with experience in successfully providing rehabilitative services to persons who have been convicted of a criminal offense.
 - When applying for this position, be sure to specify how you meet requirement L on the application.
 - Newly appointed member will participate in the CCP's Full Committee ([see Bylaws](#)).
 - There is no term limit for this member position.
- **CCP Advisory Workgroup Member:**
 - The CCP Advisory Workgroup will replace the Statistical Working Group.
 - The updated CCP Advisory Workgroup will include local agency stakeholders and community representatives.
 - Preference will be given to members from the community with the lived experience of being formerly incarcerated.
 - CCP Advisory Workgroup is tasked with conducting analysis and making recommendations to the CCP regarding additional AB 109 Plan updates that:
 - Incorporate further findings and input from local agency and community stakeholders, including formerly incarcerated individuals.
 - Align the AB 109 Plan format and content with the new BSCC recommendations.
 - Ensure County Board of Supervisors approval of the updated AB 109 Plan during the next fiscal year budget process.
