**1. Call to Order:**

A quorum was present, and the meeting convened at 10:37 a.m.

- a. **Guest Speaker** – Lt. Lisa Hinz from the City of Sacramento Police Department (SPD) provided information on the new Youth Services Division she manages. The SPD Youth Services Division is responsible for coordination of youth programs, School Resource Officers, Magnet Academy and various other programs for youth. Lt. Hinz also is the president of the non-profit organization Kops 'n Kids (<http://www.kopsnkids.com>), which provides a low, or no cost, youth day camp every summer at Rosemont High School.
