# **Presentation**

# 5. Boys and Girls Clubs of Greater Sacramento

Maureen Price, the CEO of Boys and Girls Clubs of Greater Sacramento (BGCSAC), and David Guillory, Branch Director of the Raley's Teen Center (located at 1117 G Street), provided a presentation to the Commission. The Boys and Girls Clubs of America (BGCA) is the national parent organization for the local clubs. The BGCSAC follows the national guidelines, but is able to provide programming based on the needs of the community it is serving. BGCSAC provides youth ages 6-18 with a safe environment to participate in positive activities such as art, dance and sports, learn health and life skills, and receive educational assistance. The cost for participants is \$15 annually, but scholarships are available. The average cost to provide services is \$13,000-\$16,000 per year, per youth. Approximately 53% of participants are boys and 47% are girls. Regular

attendance at the clubs has been shown to decrease tardiness, absences, behavioral issues, risky behavior, and recidivism. Transportation has been the main obstacle in regular attendance. It costs about \$25,000 per year for a bus. BCGSAC staff are working to secure funding for a bus for the Lemon Hill club. The Raley's Branch has been turned into a teen's only center focusing on academics, high school graduation and job skills. BCGSAC is currently looking for various activity and programming leaders for the new Teen Center. BCGSAC has been awarded a delinquency intervention grant through its parent organization BGCA, and are in the process of developing the grant program. The grant will target 2nd time offenders ages 10 – 17. Probation will be providing the referrals to the delinquency intervention program. BGCSAC is also planning to partner with Sacramento Police Department to begin implementation of activities with the Police Activities League soon. The Commissioners were invited to tour the local clubs.

Commissioner Dulay requested a link to the national Office of Juvenile Justice and Delinquency Prevention (<a href="http://www.ojjdp.gov/">http://www.ojjdp.gov/</a>) be added to the public DPC website.

## 7. Probation Zip Code Breakdown:

Brian Lee shared a map depicting where juvenile probationers reside in the County. The highest concentration of need appears to be along the Interstate 99 and Interstate 80 corridors - downtown Sacramento, South Sacramento (95823) and Del Paso Heights (95838).
