- 5. Lieutenant Lisa Hinz of the Sacramento Police Department conducted a presentation to the commission regarding Sacramento Police Departments Youth Services Division. The division conducts high visibility patrol, truancy sweeps, interventions and mediations, diversion program referrals, progressive enforcement model, mentors, and coach youth for the Natomas Unified School District and Sacramento City Unified School District. Lt. Hinz provided the commission information regarding the Criminal Justice Magnet Academy, the annual Kops-N-Kids program, the Sacramento Police Department Cadet Program, Police Activities League, and the Juvenile Justice Jeopardy.
- **6.** Information was announced regarding the Juvenile Justice Commission Scholarship Program.
- 7. Sacramento County Probation Departments Assistant Chief Mike Shores shared with the commission that Sacramento County Probation Department has School Resources Officers assigned to a few schools in the Sacramento County region providing services similar to Sacramento Police Departments Youth Services Division has to offer. Assistant Chief Shores was interested in integrating the Juvenile Justice Jeopardy to fit with the Youth Orientation at the Youth

- Detention Facility. The Juvenile Justice Jeopardy teaches youths about the law that affects them and the consequences if they break such laws.
