## SUMMARY OF MINUTES

March 15, 2016

- 1. **CALL TO ORDER:** A quorum was present, and the meeting was convened at 10:03 a.m. Commissioner Carole D'Elia welcomed participants.
- 2. **Approval of Minutes FROM THE FEBRUARY MEETING**: Commissioner Dan Okada motioned to approve the February minutes; the motion was seconded by Commissioner Fred Mills and unanimously approved.

- 6. **COMMENTS FROM PROBATION:** Mike Shores distributed a handout produced by "i.e. communications, LLC" on Crossover Youth. Mike Shores reported that it was a big initiative that they have been working on for a while and Judge Boulware Eurie and Michelle Callejas were also involved in producing the handout.

A brochure was emailed out to the Commission on the Adolescent Brain Development Summit that is being held on April 29<sup>th</sup>. Commissioner Dan Okada asked if the Commission would be able to receive a discount. Mike Shores informed the Commission that he would look into and get back to them.

- 7. **YOUTH DETENTION FACILITY POPULATION REPORT:** No report was given at the meeting. Probation will be sending out the report in the near future.
- 8. **PLATFORM UPDATE:** A full update will be given in April. Commissioner Fred Mills reported that they have been looking at the goals and objectives of other Commissions across the State and

they are in the process of developing a draft brochure that will appropriately represent the Commission. Commissioner Hillary Gaines will also be putting the brochure in electronic format with a PDF version that will eventually be available online. They are hoping to send the draft brochure out to Commission members in an effort to allow members to review and provide recommendations at the April meeting. Commissioner Hillary Gaines also expressed interest in developing speaking points for the Commission. Consensus was to complete the brochure first and then look at developing speaking points in the future.

### 9. DETENTION & RE-ENTRY WORKGROUP:

a. **TRANSFER OF KNOWLEDGE WORKSHOP:** Commissioner Fred Mills informed the Commission that they met with Probation and learned that Probation is already doing an excellent job in the area of re-entry and requested that Probation provide a presentation at a future meeting. Mike Shores agreed to have representatives from Probation come to the May meeting to provide an overview of their program.

There was a settlement between the County and City with Motel 6 in which Motel 6 will be contributing an undisclosed amount to the District Attorney's Office Public Safety and Community Improvement Trust Fund, which in turn would go toward human trafficking, domestic violence, and youth intervention programs. Youth groups can apply directly to the DA office for funding requests.
