Currently, there is not a program like this in Sacramento; however there may be plans to possibly replicate it with American River College.

Commissioner Carole D'Elia mentioned the JJC Scholarship would be something to look into utilizing with this group if we do establish this program in Sacramento.

The Youth Detention Facility will be holding their first Parent Orientation Night, Thursday, May 19, 2016, from 5:30 to 7:30pm.
