SUMMARY OF MINUTES March 20, 2018

Commissioner Claar asked if the data (4,249) reported on slide 7 of the PowerPoint regarding Intensive Outpatient is included in the Outpatient number (7,672). Quinley responded both numbers are separate data.

Commissioner Rios asked if Quinley can provide school attendance data of JJDTP participants to the team. Quinley mentioned he will provide the data to the group.
