1. **CALL TO ORDER:** A quorum was present, and the meeting was convened at 10:12 a.m.

  5. **COMMENTS FROM PROBATION:** Chief Marlon Yarber announced the Youth Detention Facility (YDF) is a finalist for the 2018 Barbara Allen-Hagan Performance Based Standards (PbS) award. A film crew from PbS toured the facility and produced a video showcasing YDF's innovative programming for release at the PbS conference in early August. The video will be made available to the Commission when it goes live on the PbS website.
  6. **YOUTH DETENTION FACILITY POPULATION REPORT:**  
Commissioner America Velasco discussed that the Commission would like to amend the Youth Detention Facility Population Report to include suicide attempt counts.  
  
Presiding Judge Jerilyn Borack discussed that looking into suicide attempts reporting and what we do as followup, we as a group, can recommend to the Board for additional services to address these issues and provide additional training to officers.  
  
Commissioner Hillary Gaines asked if the 300 status youth in the YDF report included in the Total Count breakdown. Chief Yarber clarified that the breakdown includes the 300 status youth.

- Paper Tigers - The movie focus on how a high school changed its approach to discipline to help students overcome traumatic events.
- Resilience – The movie focus on how the medical/health care system use a new movement to treat and prevent toxic stress.
