There was a question concerning the reasons 300 dependents are detained in the Youth Detention Facility (YDF). Chief Yarber mentioned 300 dependents are detained in YDF for various reasons: findings of the Court, alternative housing, etc.

Commissioner Dan Okada asked Probation to arrange a tour of the Children's Receiving Home for the Commission.

Commissioner Gwen Jackson-Tucker asked Probation to provide the new DPC members with a copy of the ACEs PowerPoint presentation.

Commissioner Virginia Maulfair asked Probation to invite the YDF's mental health coordinator to provide an overview of in custody and community-based mental health services.

Chief Deputy Dave Semon announced Probation hired a dietitian for the institution. Beginning in August, the institution will increase meal portion size for the female population as well as increasing snack portion for the males.
