SUMMARY OF MINUTES

February 19, 2019

- **5. COMMENTS FROM PROBATION:** Chief Semon stated: The Youth Detention Facility (YDF) was recently recognized for the CSAC Challenge award, for the MSDR room. As a result of this recognition, YDF had three youth participate in a video. We will share the video with the committee once it has been released.

We recently finished an Academy and have 18 new Probation Assistants who will be sworn in tomorrow, downtown. We are scheduled to begin a new Academy class in April.

6. YOUTH DETENTION FACILITY POPULATION REPORT:

Currently, the Youth Detention Facility has 125 residents (12 females and 113 males). Average length of stay is approximately 30 days.

Commissioner Claar asked about the requested homeless and foster care information. She would also like to know the number of youth who have graduated and the number of youth in the college program. SCOE staff are gathering the requested data and preparing a future presentation.

Commissioner Gaines is requesting information regarding Probations on site school supervision. How many youth are on formal probation? How many youth are on informal probation? Why has there been a reduction in the number of school probation officers? Why are the school officers in the field so often? Probation will gather this information and respond to the commission.

Commissioner Mejia stated she has met with commissioners from other counties to discuss future collaboration and possibly a Tri-County Commission.

Commissioner Mejia asked what the commission would like to accomplish this year and requested suggestions for Scholarship events.
