4. Discussion After-Care for Youth Recently Released from YDF and Discussion on Juvenile Field.	Probation Staff
<p>Probation staff gave a PowerPoint presentation of the Juvenile Field Services. The presentation provided an overview of two areas of Juvenile Field Services, service planning and re-entry coordination. The YDF and VOYA offer a wide array of programs that support re-entry/supervision goals. These include education, vocation, life skills, mentoring, recreation, and spiritual programs. The Redy-Go! re-entry planning is a coordinated effort for a youth's transition and reintegration into the community by assessing strengths and needs, developing an individualized plan, creating connections to community-based services and family engagement. The VOYA re-entry program follows each youth through the Secure Track commitment and provides continuous, focused case management. Connections are made with family and personal support, which includes a pre-release Home Evaluation. VOYA Re-Entry Officers assist the youth with developing their own Re-Entry Case Plan and officers continue to provide Step-Down and post-discharge community supervision. Placement of youths after release continues to be one of the biggest challenges, finding suitable housing that is conducive to rehabilitation is something that officers are constantly having to contend with.</p>
