WELCOME CHIEF PROBATION OFFICER MARLON YARBER

We are excited and happy the Sacramento Superior Court appointed Marlon Yarber as our new Chief Probation Officer of Sacramento County on October 22, 2021.



Chief Yarber's leadership abilities, extensive knowledge, and compassion make him the perfect fit to continue our mission of supporting positive change both in the department and in the community.

Marlon Yarber holds certificates in leadership and a Bachelor's Degree in Psychology from the University of California, Davis. He was also a 2016 Annie E. Casey Foundation nominee.

Chief Yarber started his community corrections career as a volunteer youth mentor in the Del Paso Heights neighborhood of Sacramento. He served as

a Youth Service Project Director for a community-based organization overseeing mentoring and after school programs. For four years, he worked for the Stanislaus County Probation Department with gangs and high-risk offenders.

Marlon Yarber transferred to the state to work for California's Criminal Justice Planning Office overseeing the landmark Juvenile Accountability Grant and then served as Deputy Director for the Corrections Standards authority for five years. He was involved in several state and federal initiatives including Juvenile Justice Realignment.

Marlon Yarber returned to community corrections and served as the Assistant Chief and Interim Chief Probation Officer for Yolo County Probation before transferring to Sacramento County Probation in 2013. As Assistant Chief Probation Officer, he had oversight of Adult Operations for Sacramento County Probation from 2013 through 2018 and then transitioned to Juvenile Operations with responsibilities in community supervision institutional services for over 1,300 youth. Mr. Yarber has been the Interim Chief Probation Officer since May 2021.

Chief Yarber's extensive history with Sacramento County Probation, his diplomatic and personable leadership style, demonstrated expertise in leading a large department during challenging times, flexibility and honesty, and his first-hand knowledge of Probation and County processes will enable Chief Yarber to lead the Probation Department into a new era of increased collaborative partnerships with County departments and community stakeholders.

Chief Yarber told the Court, "I am both honored and humbled by the support and trust placed upon me by the Sacramento Superior Court to serve as Chief Probation Officer for the County. Having played a significant role in the transformation of the department over the past seven plus years, I am proud to lead our highly skilled workforce in addressing the myriad of challenges we face. I look forward to partnering further with all of our stakeholders, including community, in pursuit of shared public safety goals."

Department of Justice Bureau of Firearms Sweep

On October 13, 2021, Probation officers assigned to the Adult Field and Adult Community Corrections divisions assisted Department of Justice agents with conducting home visits on adult clients assigned to the Domestic Violence caseload who have at least one firearm registered in their name. Probation focused on approximately 140 individuals and 70 addresses in Sacramento County for this sweep.

On October 14, 2021, the Probation Gang Suppression Unit (GSU) and the Sheriff Office GSU conducted an after-hours operation in the City and County of Sacramento. The purpose of this operation was to contact known gang members/associates and conduct probation searches, with the intent of helping suppress and prevent future gang related violence. Officers contacted probation clients and conducted several probation searches.



Family Violence Sweep

In recognition of National Domestic Violence Awareness month, Sacramento County Probation Department conducted a countywide sweep on October 20, 2021 to perform compliance searches, serve warrants, attempt arrests of individuals in violation of their terms and conditions of probation related to family violence, and refer victims to services. Officers provided victims with a Domestic Violence 24-hour Crisis Hotline and Resources card, Sacramento Regional Family Justice Center cards and brochures, and referral material from the Sacramento County District Attorney's Office Domestic Violence Victim Witness Program.

5700 Block of San Marcos, North Highlands Officers assigned to the North Adult Day Reporting Center conducted a probation search at the residence of two adults, one of whom is prohibited from possessing firearms

Both adults were arrested for Possession of Controlled Substance While Armed; Possession of Methamphetamine for Sale; Felon in Possession of a Firearm; Prohibited Person in Possession of a Firearm; and Criminal Conspiracy to Commit a Crime.

The adult was arrested for Felon in Possession of a Firearm; Receiving Stolen Property; Unlawful Possession of Ammunition; Possession of a Controlled Substance for Sale; Possession of Methamphetamine for Sale; and Possession of Controlled Substance While Possessing a Firearm.

October 13,, 2021

9000 Block of Greenback Lane, Orangevale The Sacramento County Cal-MMET/HIDTA team* executed a search warrant at the residence of an suspected of operating a psilocybin mushroom cultivation operation. During the search, detectives located evidence of psilocybin manufacturing/sales, over 200 grams of processed mushrooms, a 9mm caliber handgun, a .223 caliber rifle, numerous rounds of ammunition and over 170 grams of suspected narcotics counterfeit pills. The adult was arrested and is pending charges for Possession of Controlled including Substance for Sale and Assault upon the Person of Another with a Semiautomatic Firearm.

<u>CAL-MMET/HIDTA</u>: The California Multi-Jurisdictional Methamphetamine Enforcement Team is a partnership between the Sacramento Sheriff's Office and Probation. Cal-MMET's goal is to identify, disrupt, and dismantle methamphetamine and other drug trafficking organizations in the Sacramento region. The probation officer assigned to Cal-MMET maintains and monitors a caseload of clients placed on supervision for drug offences.

HIDTA: High Intensity Drug Trafficking Area program, created by Congress with the Anti-Drug Abuse Act of 1988, provides assistance to federal, state, local, and tribal law enforcement agencies operating in areas determined to be critical drug-trafficking regions of the United States.

Honor Guard Assists Alameda County Probation in Tribute to Fallen Officer

Established in 2019, Probation's Honor Guard is comprised of officers with varying duties and responsibilities who, in addition to their regular duties, are selected to train and be available for Honor Guard/Color Guard details.

First Responders Relay

On October 16, 2021, officers from the Sacramento County Probation Department and the Sacramento County Sheriff's Department participated together in the inaugural First Responder Relay hosted by the California Police Athletic Federation. Thirty teams consisting of Law Enforcement, Fire, and retired personnel participated in the 48-mile relay in Henderson, Nevada. Nine officers (seven Sacramento County Probation officers and two

Sheriff Deputies) made up the Sacramento County team competing. Two additional probation officers supported the team: one rode the mandatory follow-bike and the other provided mandatory assistance services during the relay.

The Sacramento County team finished in 3rd place in the Open Division.

Firearms Training

Seventeen probation officers completed a mandatory four-day Firearms Familiarization Training course to meet Penal Code 832 training requirements. Officers completed an eight-hour classroom portion followed by 24 hours of range time and capped off the week with an eight-hour Taser certification course.



All officers passed the course; many in the class had no prior firearms experience, which is a testament to their ability and the quality of the training.







Community Collaborations

Jail Diversion Treatment and Resource Center (JDTRC) Update

- October 19, 2021: Probation hosted a public Zoom webinar event announcing the JDTRC and fielding questions via the Q & A function.
- October 18-22, 2021: Probation, Behavioral Health Services and Public Defender staff met to finalize the handoff process between agencies for JDTRC participants.
- November 2, 2021: Probation updated the JDTRC website.
- November 4, 2021: Beneficial Occupancy granted. The building is now being prepared for occupancy.
- December 9, 2021: Small ribbon cutting ceremony and open house.
- December 13, 2021: Public opening planned date.



Praise for Officers Connecting with Clients

- On October 26, 2021, a Central Adult Day Reporting Center (ADRC) client reported to the probation office for ADRC. After class, he joined a casual conversation about football with several officers. He later told his probation officer how beneficial and happy he was to be having this positive relationship with law enforcement officers. He said he had never been around officers when he wasn't in trouble, and he was actually getting a lot out of his classes.
- Officers assigned to the Black Child Legacy Foothill Farms/North Highlands unit operated a drive through Trick or Treat event, delivered clothing to youth, and delivered 10 meals to families.
- A Senior Deputy Probation Officer in Juvenile Field Services secured spots for 60 families for this year's holiday food and toy giveaway. The officer is seeking assistance from officers assigned to Juvenile Field, Adult Field, and Adult Community Corrections to identify families in need.
- A Deputy Probation Officer (DPO) in the Juvenile Field Services Age of Majority unit is supervising approximately 40 individuals. Of those, 22 currently have gainful, legitimate jobs. The DPO was commended for his efforts in being a resource and providing motivation and guidance to youth.

October 1, 2021 - Officers Help Prevent House Fire Near Kiefer Boulevard and Mayhew Road

Juvenile Field Services officers noticed what appeared to be smoke coming from a house near Kiefer Boulevard and Mayhew Road. The officers entered the backyard and called out to anyone who may have been inside the home. Two construction workers inside reported they had attempted to extinguish an electrical fire in the attic, but officers noticed large amounts of smoke were still coming from the attic vents outside the house and on the roof. Officers contacted Sacramento Metro Fire, which responded with three fire trucks in a matter of minutes. The quick action by probation officers saved the home from more fire damage.











October 20, 2021 - Officers Protect Safety at Accident Scene at Fruitridge and Power Inn Roads


YDF Competitions Keep Kids Moving, Creating, and Learning

Housing Unit **Disneyland - 3rd Place** Residents painted these pumpkins as characters you might see when walking the streets of Disneyland.










5 on 5 Basketball Tournament
