NEW RESOURCE FOR PROBATION WELLSPACE HEALTH SURE PROGRAM

2021 ISSUE 3

WellSpace Health is offering a valuable resource to probation officers and clients, Substance Use Respite Engagement (SURE), a voluntary program for adults to recover from acute intoxication.

The SURE Program is available for clients age 18 and older who have been referred by Probation or other authorized referral partners. Referral partners must stay with the client during the intake process for a warm handoff. The program does not take walk-ins.

- Officers may utilize the program as a resource when a client is intoxicated and needs a safe place to recover. SURE is a voluntary program for clients who are simply intoxicated and is not intended as an alternative to arrest/custody.
- SURE offers clients access to a resting pod of either a mattress or recliner, restrooms, drinks and snacks, and clean temporary clothing. WellSpace Health staff will provide treatment services and medical referrals.

FAMILY URGENT RESPONSE SYSTEM

The County Family Urgent Response System (FURS) is a new service developed through a partnership between Probation, Behavioral Health, Child Family and Adult Services and Community-Based Services. FURS is a service for current or former foster youth (up to age 21) and caregivers where they can call and get immediate, trauma-informed support by caring and trained professionals to help with any big or small issues they may be having. This service includes a free 24/7/365 statewide hotline and 24/7 County-based Mobile Response and Stabilization support. FURS is intended to:

- Prevent placement disruptions and preserve the relationship between the child or youth and their caregiver
- Reduce the need for a 911 call or law enforcement involvement and the needless criminalization of traumatized youth
- Reduce hospitalization and placement into congregate care
- Promote healing as a family
- · Provide a safe and judgement-free space for youth and caregivers



FIREARM AND DRUG SEIZURES ON THE RISE

There is continued media interest in Probation's increased firearm and drug seizures and arrests as a result of probation officers' fieldwork. Law enforcement leaders have shared data showing a significant increase in homicides and gun cases in Sacramento County.

DISTRICT 1

February 2, 2021

300 Block of Vallejo Way

Officers assigned to the Investigation and Supervision Unit (ISU) contacted a subject with a felony no bail warrant. During a search of the subject, officers recovered a realistic BB gun, over 200 Alprazolam and Oxycodone pills, methamphetamine, a digital scale, two cell phones, and nearly \$1,000 in cash. The subject was arrested and booked into Sacramento County Main Jail and is pending charges for Possession of a Controlled Substance for Sale, Possession of Designated Substance for Sale, and Bringing Unauthorized Drugs into Jail.

February 4, 2021 6100 Block of 37th Street

Officers assigned to Adult Day Reporting Center (ADRC) South contacted two subjects on Post Release Community Supervision (PRCS), one with a Felony No Bail Warrant. Additional officers from Adult Community Corrections, Adult, and Juvenile Field Services assisted with a probation search of the residence of one of the subjects. The search recovered a stolen loaded handgun, ammunition, controlled substance pills, methamphetamine, and a stun gun. Both subjects were arrested and booked into Sacramento County Main Jail. One subject is pending charges for Possession of Narcotics, Possession of a Controlled Substance, and Bringing Unauthorized Drugs into a Jail, and the second subject is pending charges for Possession of Ammunition by a Prohibited Person, Possession of Narcotics, and Possession of a Controlled Substance.

February 11, 2021 3500 Block of South Port Drive and 9100 Block of Kiefer Boulevard

While an officer assigned to ADRC Central attempted a home compliance check of a subject on Mandatory Supervision, a second subject fled out of the rear sliding glass door and jumped fences to avoid being detained for a \$35,000 felony warrant out of El Dorado County. The second subject was later seen walking in front of a grocery store near the original residence where probation officers arrested and booked the subject into Sacramento County Main Jail for the outstanding felony warrant.

February 26, 2021 7900 Block of La Riviera Drive

Officers assigned to the South Area Post Release Community Supervision (PRCS) Unit, conducted a residence search of a subject on PRCS. The search recovered firearm optics, empty and loaded handgun magazines, and a large amount of live ammunition. A search of a rental vehicle belonging to a second subject recovered a handgun. The subject was arrested and booked into the Sacramento County Jail and is pending charges for Felon in Possession of a Firearm and Possession of Ammunition by a Prohibited Person. The second subject was cited for Possession of a Concealed Firearm in a Vehicle.



DISTRICT 2

February 11, 2021

8300 Block of Hemingway Drive

Officers assigned to the Age of Majority (AOM) Unit conducted a residential search of a subject on Juvenile Searchable Probation. Officers recovered a high capacity firearm magazine, a BB gun replica of a handgun, two boxes of molds used to make "ghost guns", and a stolen loaded shotgun. The subject was arrested and booked into the Sacramento County Main Jail and is pending charges for Possession of a Firearm by a Prohibited Person and Possession of Ammunition by a Prohibited Person.



6900 Block of Milbrook Way

Officers assigned to the South Area PRCS Unit conducted a residential search of a subject on Mandatory Supervision and recovered a firearm with a removed serial number. extended magazine containing multiple rounds of live ammunition, methamphetamine, and multiple digital scales. The subject was arrested and booked into the Sacramento County Main Jail and is pending charges of Felon in Possession of a Firearm. Possession Ammunition by a Prohibited Person, and Possession of Controlled Substance for Sale.



February 18, 2021 8200 Block of Preston Way

Officers assigned to the AOM Unit contacted a subject on both Juvenile and Adult probation. A search of the subject's room revealed a small safe that contained a loaded handgun, hundreds of dollars in cash, ammunition, processed marijuana, packaging, and a digital scale. The subject was arrested and booked into the Sacramento County Main Jail and is pending charges for Felon in Possession of a Firearm, Possession of Ammunition by a Prohibited Person, and Possession of Marijuana for Sale.



February 25, 2021 900 Block of E Street

Officers assigned to the Age of Majority unit contacted a subject on Juvenile Probation. A search of the subject's residence, revealed a handgun with an extended magazine and multiple grams of marijuana. The subject was arrested and booked into the Sacramento County Main Jail and is pending charges for Possession of a Firearm by a Prohibited Person, Possession of an Undetectable Firearm, and Manufacturing a Large Capacity Magazine.



DISTRICT 4

February 2, 2021 4400 Block Shandwick Drive

Supervision Unit (ISU) conducted a home visit of

a subject on two grants of Formal Probation. A search of the subject's room revealed a loaded handgun. The subject was arrested and booked at the Sacramento County Main Jail and is pending a



charge of Felon in Possession of a Firearm.

February 2, 2021 6400 Block of Tupelo Drive

Officers assigned to the Office of Traffic Safety/Driving Under the Influence Unit (OTS/ DUI) conducted a search of a subject's residence on Formal Probation. Officers recovered a semi-automatic pistol, over 60 rounds of ammunition, several hundred psychiatric pills, and a working scale with white residue. The subject was arrested and booked into Sacramento County Main Jail pending a Violation of Probation and charges of Felon in Possession of a Firearm and Possession of Ammunition by a Prohibited Person.



February 4, 2021 7000 Block of Lynnetree Way

Officers assigned to the OTS/DUI Unit conducted a search of a subject's residence on Formal Probation. Officers recovered two pistols, approximately 100 rounds of live ammunition, and over two grams of presumptive positive cocaine. The subject was arrested and booked into Sacramento County Main Jail pending a Violation of Probation and charges of Felon in Continued on Page 6

Possession of a Firearm, Possession of Ammunition by a Prohibited Person, and Possession of a Controlled Substance.



February 16, 2021 2400 Block of Santina Way

Officers assigned to ISU contacted a subject on active parole. After further investigation, officers obtained a search warrant for the subject's residence. A search of the residence recovered a "ghost gun" firearm, numerous rounds of pounds of processed ammunition, several marijuana, over 25 grams of approximately 30 grams of heroin, Hydrocodone and Oxycodone pills and over \$14,000 in U.S. currency from a second subject's room. The second subject was arrested and booked into the Sacramento County Main Jail and is pending charges of Felon in Possession of a Firearm, Possession of Ammunition by a Prohibited Person, Possession of a Controlled Substance, Possession of Controlled Substance for Sale, and Possession of Marijuana for Sale.



DISTRICT 5

February 8, 2021 - Kiefer Boulevard A subject on Juvenile Probation was directed to report to the Probation office. Upon arrival at the office, the subject was observed getting out of the backseat of a vehicle with two other occupants.

Officers assigned to the Age of Majority (AOM) unit contacted the two occupants of the vehicle and determined they were on Juvenile Searchable Probation. A search of the vehicle revealed a stolen loaded handaun. Oxycodone methamphetamine. All three marijuana. and subjects were arrested and booked into the Sacramento County Main Jail. One subject is pending a Violation of Probation. Another subject is pending charges for Felon in Possession of a Firearm, Possession of Narcotics, and Possession of Controlled Substance. The third subject is pending charges for Carrying a Loaded Firearm on One's Person and Possession of Controlled Substance.

THE REAL PROPERTY OF THE PARTY OF THE PARTY

February 19, 2021 3300 Block of Virgo Street

An officer assigned to the California Multi-Methamphetamine Jurisdictional Enforcement Team executed a search warrant in Sacramento. The search revealed over 1600 grams of narcotics methamphetamine, cocaine, Oxycodone pills, and MDMA (Ecstasy/Molly). Also seized was a digital scale, ballistic vest, stolen motorcycle, a revolver, two handguns, and over \$900 in U.S. currency. The subject was arrested and booked in the Sacramento County Main Jail and is pending charges for Possession of Heroin for Sale, Possession of a Controlled Substance for Sale, Possession of a Controlled Substance While Armed with a Loaded Firearm, Felon in Possession of a Firearm, and Felon in Possession of Body Armor.

• Collaborative Courts held approximately 183 hearings to include four graduates.



 February 16, 2021: Recovery Court started offering in-person groups again. Case managers provide approximately 15 weekly group sessions with approximately two to six clients per class.

MORE ADRC SUCCESSES

- February 16, 2021: ADRC-North resumed in-person classes for clients. Attendance was good for all sessions, and case managers reported how positive it was to engage with the clients in person.
- One client obtained employment as a dispatcher for a material handling company.
- One client was referred to <u>Northern California Construction Training (NCCT)</u>, a pre-apprenticeship program designed to prepare men and women for a career in the construction industry. The client is very appreciative of the referral and is excited to begin working with NCCT.





Community Partnerships Going Strong

JUVENILE JUSTICE COORDINATING COUNCIL

Probation hosted a public <u>Juvenile Justice Coordinating Council (JJCC) Subcommittee</u> workshop via Zoom on March 8, 2021 to increase public engagement. The workshop included information about DJJ Realignment and SB 823, subcommittee membership requirements, and a walkthrough of the new JJCC Subcommittee website and membership application. Membership applications are due on March 22, 2021.





JAIL DIVERSION TREATMENT AND RESOURCE CENTER UPDATE

February 3, 2021: Probation received approval from both the County of Sacramento and the City of Sacramento for building permits. Outback Contractors, Inc., the contractor hired to perform the renovation, may now finalize their cost estimate knowing there will be no further building code mandated changes.



COUNTYWIDE TRAINING UPDATES

Universal Trauma Training

Universal Trauma training kicked off on February 9. Additional sessions were offered in February and will continue to be offered throughout March. Additional sessions may be offered in April

Implicit Bias Training

Executive leadership from Probation, the Department of Child, Family and Adult Services, and Behavioral Health Services have organized implicit bias training for leadership across the three departments. Nation-wide expert, Dr. Bryant Marks, delivered the first training session on February 1 and the second session on February 18.

Community Supervision Black Child Legacy Campaign (BCLC) Unit

On February 26, 2021, Officers with the BCLC unit participated in the Phoenix Park Food Distribution project handing out food and hygiene products to families of Probation clients.

In February, two Adult Day Reporting Center Central clients were placed in Nextmove Mather Housing and another was referred to Nextmove with the assistance of Probation.

The YDF Library honored Black History month, featuring books by Black authors and giving youth the opportunity to earn free books. Residents were excited about earning books for themselves or family members. The YDF Library gave approximately 60 books to residents during February.
