Welcome Interim Chief Marlon Yarber



Marlon Yarber was appointed Sacramento County Interim Chief Probation Officer in April 2021. He began his career with Sacramento County Probation in 2013. He provided oversight of Adult Operations between 2013 and 2018 and then transitioned to Juvenile Operations. Before joining Sacramento County, Yarber served as Deputy Probation Officer for the Stanislaus County Probation Department working with gangs and high-risk adult offenders.

He transitioned to the state and worked for the State of California, Office of Criminal Justice Planning overseeing the landmark Juvenile Accountability Block Grant. He was later appointed Deputy Director for the Corrections Standards Authority overseeing a variety of federal and state initiatives in California including Juvenile Justice Realignment.

In the same year, he was awarded the Kirkpatrick Professional Development Award in recognition of his work to reduce disparities in the criminal justice system. Yarber was a 2016 Annie E. Case Foundation nominee and holds certifications in leadership and facilitation and a Bachelor's Degree in Psychology from the University of California, Davis.

ACPO Wherry currently oversees the operation of the

Pre-Trial Release and Monitoring program, a transition to provide risk-based assessments on individuals in

custody to be considered for release in lieu of a release system based on wealth.

Wherry values collaboration, empowerment, innovative ideas, efficient processes, continuous improvement, and data outcomes.

ACPO Wherry is a California State University, Sacramento (CSUS) graduate and a member of the CSUS Criminal Justice Advisory Committee.

Recovery Court In the Spotlight

Since 1995, the Sacramento County Recovery Court program has been an effective, evidence-based solution to addiction and criminal behavior.

Formerly Known As Drug Court

Sacramento County launched the Drug Court Pilot Program in May 1995, using the first national drug court established in 1989 in Miami-Dade County, Florida as a model.

The Drug Court Pilot was a collaborative effort between law enforcement and health officials.

Program goals included increasing awareness of drug abuse/ addiction, increasing the ability of participants to live drug-free, providing clients access to community resources that support positive lifestyle changes, and reducing drug related crime and recidivism.

In December 1995, Drug Court received a federal grant to continue its efforts on a larger scale.

Recovery Court

Drug Court was restructured and renamed Recovery Court, an effective, evidence-based solution to addiction and criminal behavior.

Because they don't serve prison time, Recovery Court graduates save the County and state thousands of dollars in prison

costs. Even non-graduates serve one-third the prison time compared to those who did not participate in the Recovery Court Program.

In January 2020, the Recovery Court Unit opened its doors to allow for expansion of the Recovery Treatment Center.

Recovery Treatment Center (RTC)

People arrested for non-violent drug related offenses, violations of probation, or certain property crimes may participate in the RTC program for approximately 8 to 12 months.

The RTC provides on-site: • Outpatient drug/alcohol treatment • Individual and group counseling • Family counseling • Nutrition Education • Gardening • Yoga • Pro-social activities • Mental health services • Frequent drug testing • Probation supervision in the community

The RTC also offers detox, residential, and sober living for clients who qualify.

Offenders who are accepted are placed on probation while their State Prison or County Jail Prison sentence is suspended pending program completion.

Keeping Our Community Safe

ALL DISTRICTS Gang Violence Suppression Sweep April 15, 2021

Officers assigned to the Juvenile Field Age of Majority (AOM) Unit participated in an after-hours Gang Violence Suppression (GVS) sweep to perform compliance checks on probationers assigned to juvenile field. The GVS Operation is part of a grant collaboration with the City of Sacramento to address gang violence in areas hardest hit by gun violence and gang activity. The purpose of the operation was to ensure compliance with clients' Terms and Conditions of Probation. Six home visits and probation searches were conducted resulting in, one Violation of Probation, and one fresh arrest for Felon in Possession of Ammunition.



GVS Sweep Results:

- Home Visits Attempted: 8
- Probation Search Conducted: 6
- Fresh Arrests: 1
- Drugs Seized: Approx. 84 grams marijuana
- Ammunition Seized: 15 round extended magazine
- Surveillance/Intel Gathering: 1

SAFE Team Sweep April 29, 2021

Adult probation officers coordinated Field Probation/Parole compliance checks on registered sex offenders to ensure compliance with their Terms and Conditions of Probation/Parole and their requirement to register as sex offenders. The compliance checks were conducted by the Sacramento Sexual Assault Felony Enforcement (S.A.F.E.) Team comprised of officers from the Sacramento County Sheriff's Office, Sacramento County Probation Department, Sacramento Police Department, and Parole. They were further assisted by Juvenile Field probation officers, Elk Grove Police Department, and Department Of Justice. One subject was arrested for Felony Warrants for Battery Against a Peace Officer and for a Stolen Vehicle. Further investigation will be conducted on hidden electronics that were recovered.



SAFE Sweep Results:

- Home Visits and Searches: 24
- Home Visits Attempted: 17
- Warrant Arrests: 1
- Surveillance/Intel Gathering: 1

All officers involved in these operations adhered to the safety guidelines in place by Sacramento County in response to COVID-19. Officers Personal Protective Equipment and had additional masks for individuals contacted in the home.

DISTRICT 1

April 16, 2021 8900 Block of Rosewood Drive

Officers assigned to the Adult Field Post Release Supervision (PRCS) Community South Unit conducted a residential search of a subject on PRCS. Officers recovered an empty firearm box, empty firearm magazine, and multiple rounds of live ammunition. With the assistance of a K-9 Unit from the California Department of Justice (DOJ), officers were alerted to a fully loaded firearm located behind a futon in the subject's room. The subject was arrested and booked into the Sacramento County Jail and is pending charges of Felon in Possession of a Firearm and Possession of Ammunition by a Prohibited Person.



April 27, 2021 8745 Folsom Blvd

A subject reported for an office appointment at the Folsom Boulevard Probation location with Adult Day Reporting (ADRC) Central officers. The subject reportedly did not drive to the appointment, but upon leaving the appointment, the subject was witnessed entering a vehicle that was reported stolen out of Santa Rosa. He subject was arrested and booked into the Sacramento Main Jail and is pending charges of Vehicle Theft and Possession of a Stolen Vehicle.

April 28, 2021 9500 Block of Folsom Boulevard



Detectives with the California Multi-Jurisdictional Methamphetamine Enforcement Team Unit (Cal-MMET), in conjunction with the Probation Department and Rancho Cordova Police Department conducted a search of a subject on Formal Searchable Probation. Officers recovered methamphetamine, heroine, narcotic packing material, and a digital scale. The subject was arrested and booked into Sacramento Main Jail and is pending charges for Possession of Controlled Substance for Sale and Possession of Non-Narcotic Substance for Sale.

DISTRICT 2

April 13: 2021 7700 Block of 39th Avenue

Officers assigned to the Family Violence Unit conducted a residential search of a subject on Formal Searchable Probation. Officers recovered methamphetamine, narcotics pipes, and capsules of hydrocodone, suboxone, and buprenorphine. The subject was arrested and booked into the Sacramento Main Jail and is pending charges of Unlawful Possession of a Controlled Substance, Possession of Narcotic Paraphernalia, Possession of a Dangerous Controlled Substance, and Possession of Narcotics.



DISTRICT 3 April 5, 2021

Officers assigned to the Investigations and Supervision Unit conducted a residential probation search of a subject on Formal Searchable Probation. During the search, officers recovered a loaded handgun, and live ammunition. A second subject who was already pending charges for

Carrying a Loaded Firearm and Carrying a Loaded Unregistered Firearm was arrested and booked into the Sacramento Main Jail pending charges for Accessory and Illegal Transfer of a Firearm



DISTRICT 5

April 5, 2021 10500 Block of Peter A. McCuen Avenue

Central ADRC officers conducted a compliance check of a subject on Formal Searchable Probation. The search recovered over \$5,000, oxycodone pills, marijuana, a digital scale and a couple pocket knives. The subject was arrested and booked into Sacramento Main Jail on a Violation of Probation and Possession of a Controlled Substance for Sale.







April 28, 2021

Detectives with the California Multi-Jurisdictional Methamphetamine Enforcement Team Unit (*Cal*-MMET), in conjunction with the Probation Department and Rancho Cordova Police Department conducted a search of a subject on Formal Searchable Probation. Officers recovered methamphetamine, heroine, narcotic packaging material, and a digital scale. The subject was arrested a booked into the Sacramento Main Jail and is pending charges for Possession of Controlled Substance for Sale and Possession of Non-Narcotic Substance for Sale.

April 28, 2021 Elk Grove Burglary Sweep

Officers assigned to the South ADRC Unit assisted Elk Grove PD with a "high visibility" sweep to address area businesses impacted by a series of recent burglaries and shoplifting. Probation compliance checks were also conducted on subjects known to be on Probation in Sacramento County, primarily with theft-related convictions. The event resulted in:

• Five (5) probation searches • Three (3) violations of probation filed • One (1) arrest

Legislation Impacting Probation

FAMILIES OVER FEES ACT ASSEMBLY BILL 1869

Beginning July 1, 2021 the Families Over Fees Act (Assembly Bill 1869) will go into effect. This bill permanently ends the assessment and collection of 23 administrative fees in the criminal justice system incurred by justice involved individuals.

These fees include the cost of booking and arrest, work release programs, home detention, electronic monitoring, probation supervision, and the cost of public defense. The bill also eliminates the requirement to pay these fees if they were previously assessed.

The bill is expected to have both immediate and long-term positive effects on justice-involved individuals, helping remove a significant financial barrier to successfully exiting the criminal justice system.

Officers & Programs Making a Positive Impact

Probation Officers Provide Emergency Aid to Community Member in Vehicle Fire

Officers assigned to the Adult Field and Family Violence Units noticed a parked van at a Light Rail Station emitting smoke. They also observed a man in a non-functioning wheel chair outside of the van and stopped to render aid. The man stated there were no other occupants of the van. Shortly thereafter, embers exited the van's engine, and officers contacted dispatch requesting emergency fire response. Firefighters responded and successfully contained the fire. The man was reunited with his family who assisted in returning him home.



ADULT OPERATIONS

Northern California Construction Training Project

The Sacramento County Probation Department (Probation) commissioned the Northern California Construction Training (NCCT) program to build an outdoor "Pull Up Bar and Dip Station" to provide officers with safe outdoor exercise equipment at Probation's Folsom Boulevard office. The project began in June of 2020, but due to Covid-19 restrictions, it took some time to complete. NCCT instructor Jack Maberry and his students started and completed the project on April 23, 2021.

Probation and NCCT have maintained an excellent professional relationship for many years. There are fourteen Probation clients currently enrolled at NCCT. As Covid-19 restrictions lift, Probation will continue to utilize NCCT and our Probation students for projects in the future.

Probation Provides Community Pharmaceutical Medication Surrender Bin

Saturday April 24 was National Prescription Drug Take Back Day. Allowed medications such as prescription and over the counter medications, medicated lotions and ointments, and pet medications can be safely disposed of at the Sacramento County Probation Department located at 8745 Folsom Blvd.

The Pharmaceutical Medication Surrender Bin is located in the Recovery Treatment Center public lobby and available Monday through Friday during normal business hours.

The <u>United States Drug Enforcement Administration</u> (<u>DEA</u>) encourages everyone to participate by safely disposing of their unused or expired prescription drugs in an authorized drug drop box to keep the public safe and to prevent the misuse of medication.

Medication disposal is a simple 3-step process!
