

Honoring National Crime Victims Rights Week April 24-30


Probation's Victim Restitution Services unit works closely with the Sacramento County District Attorney's Office and victim support organizations to help victims navigate the emotional distress and financial losses that can occur as a result of being the victim of a crime.

The Victim Restitution Unit also assists the Department of Revenue Recovery and the California Department of Corrections and Rehabilitation in obtaining contact information for victims in order to disperse funds collected for restitution, with the goal of helping make victims financially whole.

Probation officers within the Victim Restitution Unit are responsible for determining restitution as ordered by the Superior Court. To aid in the determination and recovery of restitution, the probation officer contacts crime victims to request information.

Restitution is determined for the value of stolen or damaged property, medical expenses, counseling expenses, or loss of wages or profits due to injury and funeral cost.

Probation processes over 3,800 Superior Court restitution orders annually.

Officer Utilizes Incentive Program to Motivate Youth



Community Partnership Connects Clients to Services in South Sacramento

On April 14, Probation officers partnered with the <u>Sacramento Sheriff</u> Homeless Outreach Team (HOT) and Problem Oriented Policing (POP) Team to reconnect with unhoused individuals who are on probation or Post Release Community Supervision.

The operation helped officers connect with individuals to determine what type of housing, mental health, and transportation the individuals may need to succeed on probation. Officers contacted nine adults on probation. Officers provided the adults with resources and new reporting instructions.

A probation search at one location resulted in the recovery of a stolen vehicle, which was returned to the registered owner.

Placement Unit Resource Family Approval Youth Accepted in First Star Sacramento State Academy

Deputy Probation Officer Buerger worked successfully with the <u>First Star Sacramento State Academy</u> (FSSSA) to have the first Resource Family Approval youth accepted as a special one-year cohort scholar in the four-year college readiness program offered to foster youth.

The FSSSA program will provide the youth with individual academic support to remain on track for high school graduation and prepare the youth for higher education and adulthood through mentorship and specialized programming that addresses the academics, life skills, and adult supports unique to students in foster care.

This amazing opportunity will allow the youth to attend all-day sessions held on the Sacramento State University campus one Saturday each month. In addition, the youth will participate in a three-week summer immersion program while residing in the residence hall on campus.


NAACP Prayer Breakfast

DISTRICT 1 Gang Violence Sweep Gets Firearms, Drugs, and Offenders off the Streets

Officers from Juvenile Field and Adult Field conducted a sweep on April 7, 2022 to ensure gang-affiliated juveniles were abiding by their probation terms and conditions. Officers conducted multiple searches.

April 4, 2022 2900 Block of 43rd Street, Sacramento

During a probation search of an adult on Formal Searchable Probation, officers located an unregistered .45 caliber Springfield XD firearm and magazine with 13 live rounds of ammunition. The individual was booked into the Sacramento County Main Jail pending firearm charges and a Violation of Probation.

April 28, 2022 7800 Block of Dalewoods Way, Sacramento

Officers with the Adult Field Services Gang Suppression Unit and Juvenile Field Services Age of Majority Unit conducted a probation search of the residence and vehicle of an adult on Juvenile Field Supervision.

During the search, Officers recovered 112 Grams of M-30 pills (Percocet/Fentanyl), 15 Grams of Rock Cocaine, and 180 Grams of Xanax. The individual was arrested for Possession of Illegal Drugs for Sale. During the search, a second adult arrived whom officers determined was also on Juvenile Field Supervision. Officers cited and released the second individual for Possession of a Controlled Substance (Xanax).



DISTRICT 3

April 6, 2022 Roseville Road and Stationers Way Sacramento

An officer with the Investigations and Supervision Unit (ISU) contacted an adult on Formal Searchable Probation who had two active felony warrants. With assistance from the Sheriff's Office North Problem Oriented Policing (POP) unit,, Sheriff's patrol, and the Sacramento County Sheriff's helicopter, officers detained the adult as well as a second individual.

A search revealed methamphetamine, a .22 caliber rifle, and a 9mm handgun. The individuals were arrested and charged with Possession of a Firearm by Felon; Felon in Possession of Ammunition; and Possession of Methamphetamine for Sale.

April 7, 2022 5700 Block of Callie Lane Sacramento

Probation officers conducted a probation search of the residence of an adult on Pretrial Supervision for Possession of Firearm by Felon, and Corporal Injury on Spouse or Cohabitant. The individual was also out on bail for Possession of Firearm by Felon; Threat to Commit Crime Resulting in Death or Great Bodily Injury; and Corporal Injury on Spouse or Cohabitant – Parent of Offender's Child. During the search, officers recovered a black handgun as well as a fully loaded magazine.

The adult was arrested for Possession of Firearm by Felon; Felon in Possession of Firearm; and Violating a Protective Order.





A Deputy Probation Officer with the Investigations and Supervision Unit (ISU) received a Proposition 63 referral stating an individual on Post Release Community Supervision wanted to surrender a rifle, ammunition, and illegal fireworks kept in a storage unit.

With the assistance of K-9 Hope, officers recovered an AK-47 rifle, thousands of rounds of ammunition, and illegal fireworks. The rifle and ammunition were booked for safekeeping. The fireworks were taken to a local Metro fire station for disposal.





DISTRICT 5

Compliance Sweeps in South Sacramento / Elk Grove Three Arrests - Firearms, Drugs, and Ammunition Seized

Officers with the Adult Day Reporting Center (ADRC) South, Electronic Monitoring Unit, and ADRC North conducted a compliance sweep in

South Sacramento County, specifically targeting the Elk Grove area. Officers contacted individuals on Probation, Post Release Community Supervision - continued on page 11 -

to ensure compliance with their terms and conditions of probation.

Officers conducted probation searches at target locations, resulting in two Violations of Probation, one adult arrested on charges of Possession of a Firearm with Ammunition, and three adults arrested on charges of Possession of Methamphetamine, Possession of Mushrooms (Psilocybin), Possession of Drug Paraphernalia.





Elk Grove Compliance Sweep Utilizes DOJ On-Site Forensic Analytics

April 20, 2022

The Elk Grove Police Department and Sacramento County Probation officers assigned to Adult Day Reporting Center Central conducted compliance checks of individuals on probation for domestic violence and Penal Code 290 Sex Crimes Registration with probation causes.

Additionally, members from the <u>Department of</u> <u>Justice Sacramento Internet Crimes Against</u>

<u>Children Task Force</u> were present to facilitate on-site forensic analytics and downloading of digital information from electronic devices.

This joint operation was made possible by fostering relationships with local partners and collaborating throughout the operations planning and coordination during the execution of the operation.

Officers conducted a follow-up investigation regarding a firearm recently recovered from an adult on Formal Searchable Probation that was registered to another adult on Informal Searchable Probation. Officers contacted the registered owner to determine how the weapon was acquired by the arrested individual.

A search of the residence revealed two additional firearms that were unregistered and un-serialized. Officers seized the firearms pending further investigation.

Culinary Art Program Cooks Up a Competition



Female Youth Support Justice for Ukraine


The female youth in Housing Unit 10 made posters and hung them inside of their housing unit in support of Ukraine.
