Multi-Jurisdiction Collaboration



Saturation Saturday

On August 29, 2023, in collaboration with Saturation Saturday, the Sacramento County Probation Department OTS/DUI unit conducted a DUI Warrant Sweep this past weekend in Sacramento County. This was the second warrant sweep for the fiscal year funded through a grant from the Office of Traffic Safety (OTS). Officers contacted several individuals and conducted multiple probation searches, resulting in two arrests.

The Sacramento County Probation Department supports the mission of Mothers Against Drunk Driving (MADD California). Saturation Saturday is held the weekend before Labor Day weekend, during one of the busiest and deadliest times on our roads. Every 90 seconds, a person is injured in a drunk driving crash. Bonnie, a representative from MADD whose daughter was killed by a drunk driver, participated in a ride along with two of our officers from the DUI unit. Afterwards, she forwarded the following letter to the program specialist, Lori Bergenstock from MADD.

On August 26, 2023, I had the pleasure to spend Saturation Saturday with the Sacramento Probation Team.

I wasn't sure what to expect because I knew very little about their workload and mission. The team was welcoming, warm, very interested in MADD's mission, and appreciated the information regarding MADD and her journey in honor of Irene provided by Rhonda at the briefing. They shared with me how they strive to make their mission – supporting positive change – with those with whom they work. Throughout the day, they shared how and why they chose this specific career. They explained their workload and how it has changed over the past few years. They have a unique understanding of the challenges for individuals who have become involved in the justice system while still holding them accountable for their decisions and choices. They see and experience the impact of those decisions on victims.

This was the first ride-along where we were at people's homes instead of on a roadway. We spent the day looking for those on probation who failed to comply with their probation orders associated with DUI's, often coupled with other crimes associated with their decision to drive impaired. The team completed two arrests and made contact with family/friends or found additional information on several others. I learned they wear multiple "hats", including social workers, compliance, law enforcement, and educators because they are committed to develop a positive working relationship with those who wish to make changes in their lives as well as families of those on probation. With the two arrests, they were respectful, professional, and calm, holding them accountable but maintaining their dignity. When speaking with friends/family members, their commitment to their mission is shown through. In a number of our stops, we encountered children who could become frightened with a number of individuals wearing protective gear coming up or into their home. Their approach deescalated the situation to minimize the disruption or fear.

I shared my daughter Jessica's journey and how an impaired driver changed the trajectory of her life and our lives. I shared MADD's mission and the services we offer victims as well as the programs we either sponsor or partner with other groups. Sincerely,

Sacramento County Fentanyl Awareness and Action Summit 2023

On August 17, 2023, officers from the Adult Community Corrections (ACC) Division, along with a Recovery Court counselor from WellSpace, attended the Sacramento County Fentanyl Awareness and Action Summit 2023. The event was organized by the Sacramento County Department of Health Services. It brought together community members, law enforcement, health services, and providers to educate and discover strategies to fight the fentanyl crisis. Assistant Chief Deputy Chew represented the Probation Department on the law enforcement panel to discuss the trends that our officers are seeing with our clientele. The networking and presentations were the highlight of the summit.





National Fentanyl Awareness Day

On August 31, 2023, the Sacramento County Probation Department partnered with the Department of Health Services to bring awareness to National Fentanyl Awareness Day. Narcan and educational flyers were dispersed at the Jail Diversion Treatment Resource Center (JDTRC) and the Sacramento County Recovery Treatment Center (RTC). Clients from the Adult Day Reporting Center (ADRC) Central also participated. Officers reviewed the dangers of opioid use and instructed individuals on how to properly utilize Narcan to prevent overdose in our community. Collaborations like this help educate and discover strategies to fight the fentanyl crisis.







Multi-Jurisdiction Collaboration

Compliance Operation

On August 29, 2023, the Sacramento County Probation Department, California Department of Corrections, and the Elk Grove Special Investigations Unit, teamed up for a compliance operation, surprising over 20 individuals on probation or parole.

Only a few minor violations were found; however, these operations are about collaboration with other agencies, monitoring client compliance, deterrence, maintaining accountability, and fostering a safe community for everyone.







Criminal Justice Youth Shadow Day

On August 3, 2023, Probation was invited to participate in Criminal Justice Youth Shadow Day hosted by the District Attorney's office. Our officers mentored high school youth, gave them a tour of our Adult Court Services office, and gave a short presentation explaining what it's like to be a probation officer!

At a press conference on August 17, 2023, Chief Probation Officer Marlon Yarber announced the Sacramento County Probation Department was awarded grant funding to purchase mobile outreach vehicles. He was joined by Supervisor Phil Serna-District 1, Deputy County Executive Chevon Kothari of Social Services, Assistant Chief Deputy Robyn Howland, Assistant Chief Deputy Dave Linden, and Public Information Officer Elise Vondrak to discuss how the

outreach vehicles will provide services to youthful offenders, the unhoused

and those in rural populations.

Probation is working on breaking down barriers for people in our communities, helping them to succeed while also enhancing public safety. This will be done with the support and collaboration of our community partners. We are appreciative of Placer County Probation for allowing us to use their van for tours after the press conference, as their outreach vehicle has been operating with great success since October 2021.

First Step Communities Outreach


Sacramento County Probation officers visit the First Step Communities North A Street Campus every first and third Thursday from 10 AM –12 PM. This program provides interim housing and services to the most vulnerable of the unhoused population. The First Step program then prepares them for permanent housing and connects them to services. This partnership helps break down barriers in our community.

Chaplaincy Baptisms

This month, the Chaplaincy at YDF hosted baptisms for the youth that chose to be baptized with Chaplain Tara and Chaplain Caleb. The baptisms were held at the Youth Detention Facility pool.



Mentor Program Completion

Youth participating in the mentor program completed a detailed curriculum focusing on leadership and personal development, with the goal of providing support to their peers as a mentor. Youth presented their mentor creed and shared their life story to explain why they want to be a mentor in front of their peers and staff.







Mindful Moments with MSDR

MSDR (Multi-Sensory De-Escalation Room) Mindful Moments is a group support program for youth who need additional support from staff and peers. Mindful Moments was designed to give the youth an opportunity to understand their emotions, share, and find ways to be interactive and mindful. The concepts derived from the MSDR such as identifying their emotional scale, use of sensory items, communication and various prosocial activities help the youth regulate their emotions, assist with positive interactions, and improve their decision making.
