Multi-Jurisdiction Collaboration

DUI Compliance Check

On December 16, 2023, the DUI/OTS Unit conducted a DUI compliance check throughout Sacramento County. The purpose of this operation was to contact DUI offenders to ensure compliance with their probation conditions in an effort to reduce DUI related fatalities, injuries, and DUI recidivism within the County. This was the second DUI/OTS operation funded through our Department's Office of Traffic Safety Grant for the 2023/2024 year. The following is a result of the operation:

- 13 home compliance checks were attempted
- 7 individuals were contacted
- 7 individuals were PAS tested, which included one positive test
- 7 probation searches were conducted
- 1 individual was arrested for a Violation of Probation

On December 13, 2023, the Accountability, Collaboration, Treatment (ACT) program for Adult Field held a Christmas prosocial event for their clients. Clients were able to bring family and friends to celebrate at a Christmas party with lunch, presents, and raffle prizes.

Sacramento County Probation Department has partnered with Leaders in Community Alternatives (LCA), to bring evidencebased classes that help with cognitive behavioral treatment, employment services, housing resources, mental health services, and general education referrals known as the ACT Program to our Adult Field clients. By having this program available to our clients, it assists in removing barriers for their successful re-entry into the community.







Collaborative Courts Holiday Dinner & Gift Giveaway

On December 12, 2023, our Collaborative Courts coordinated a holiday dinner and gift giveaway after receiving a generous donation from the Salvation Army and the Sacramento Sheriff's Toy Project. Our officers wrapped presents and put together dinner baskets which included a whole turkey for several deserving families.



Good Night Lights at Shriners Hospital

This is the 6th year Shriners Childrens Hospital put on a "Good Night Lights" program for the children who are hospitalized during the holiday season. Every December, a collective effort is made by local law enforcement and fire departments to illuminate the lives of children who are currently hospitalized. First responders turn on their vehicle lights and parade around the hospital so the patients can look out their windows before they go to sleep. The lights from the first responder vehicles bring the holiday spirit to the young patients that cannot leave to see the holiday lights on their own. The No Student Left Hungry program provides food to low income elementary school students and their families. The volunteers prepared 846 boxes which included 10,575 pounds of food. Through this ongoing effort, clients are able to give back to the community.

Keeping Our Community Safe

County Wide Compliance Sweeps

November 30, 2023

On November 30, officers from the Adult Community Corrections Division conducted a compliance sweep of individuals on various forms of court-ordered supervision. Officers completed home visits and searches, resulting in arrests for possession of a stolen firearm, possession of narcotics, two Violation of Probation arrests, and one felony warrant arrest. Officers seized the following:

- 1 stolen semi-automatic handgun
- Approximately \$609.00
- Approximately 75 grams of suspected Fentanyl
- 44 suspected Fentanyl tablets
- 5 unknown tablets
- 38 rounds of various caliber ammunition
- 2 scales

December 7, 2023 *Investigation & Supervision Unit* 4300 Block of 45th Ave, Sacramento

On December 7, 2023, officers conducted a compliance check on an adult individual under supervision. During a search of the residence, officers located approximately 15.05 grams of methamphetamine, 32.15 grams of Fentanyl, 15.2 grams of Xanax, scales with narcotic residue, narcotic packaging and approximately \$243.00. Subsequently, the individual was arrested on narcotics related charges and booked into the Sacramento County Main Jail.

December 15, 2023 *Impact Services Team* 2800 Block of Lerwick Rd, Sacramento

On December 15, 2023, Juvenile Field officers conducted a compliance check of two juvenile individuals under supervision. During a search of their bedroom, officers located a semi-auto handgun with a high-capacity magazine containing 4 live rounds, and a box containing various rifle parts. Both juvenile individuals were arrested and booked into the Youth Detention Facility for firearm related charges.
