Celebrating Success

Central Adult Day Reporting Center Graduation

At the Central Adult Day Reporting Center (ADRC), family, friends and staff celebrated the graduation of five clients. The ADRC program offers clients cognitive behavioral treatment interventions, substance misuse treatment, self-help courses, educational programming, connection to housing, and vocational assistance. Clients also receive family support services, participate in pro-social activities, and pay victim restitution through the Community Outreach Program.





Celebrating Veteran's Treatment Court Graduates

In December of 2023, the Veterans Treatment Court (VTC) program celebrated the graduation of six clients. The VTC clients participate in a comprehensive treatment and rehabilitation program that links veterans with benefits and services they need to break the cycle of substance abuse and criminal behavior. The VTC program has a focus of addressing mental health issues, reducing recidivism, and improving public safety through the use of judicial oversight, intensive supervision, comprehensive case management, evidence-based treatment, and drug/alcohol testing. The length of program is a minimum of 12 months. Each one of the graduates had endured a different road to recovery, however each one had an inspiring story to tell about their successful journey.



Journey to Recovery

In January 2024, a previously unhoused Recovery Treatment Court (RTC) client was able to obtain permanent supportive housing through WellSpace Health's housing navigator program and CalAIMS assistance. Shortly after moving in, Deputy Probation Officer M. Murillo secured assistance from the Assistance League of Sacramento and was able to purchase the client a brand-new bed frame and mattress. With the collaboration from Probation, WellSpace Health, and the Assistance League of Sacramento, the client now has a stable and safe environment to assist him on his journey to recovery.



Officers & Programs Making a Positive Impact

Game Day: Pro-Social Event at ADRC South

On January 30, 2024, staff from Leaders in Community Alternatives (LCA) and officers from the South Adult Day Reporting Center (ADRC), participated in a game day pro-social event with their clients. They played dominoes, card games, connect 4, and cornhole while enjoying snacks. Pro-social events celebrate the clients' hard work and dedication to making positive lifestyle changes. It also strengthens the partnership between clients, service providers, and probation.





Sacramento County Health Services Education Class

On January 18, 2024, clients from Recovery Treatment Court (RTC) participated in a Hepatitis C and HIV Education class Sacramento with the Countv Department of Health Services. Sexual Health Promotion Unit. This class is offered guarterly throughout the year to educate our clients on sexually transmitted diseases (STD's), HIV, Hepatitis A, B and C, as well as healthy hygiene. The class also included free confidential testing for our clients. Clients were provided safety pamphlets on the risks of sexually transmitted diseases, and a bag of STD prevention accessories. The Sexual Health Promotion Unit works to provide comprehensive STD services to Sacramento County through education, awareness, and access.

Sacramento County Probation and Elk Grove Police Department Collaborate for Probation Sweep

On January 24, 2024, Sacramento County Probation Department collaborated with Elk Grove Police Department on a probation sweep. Details of this sweep include:

Keeping Our Community Safe

DISTRICT 1

January 18, 2024 High Risk Probation Unit 2600 Block of Forrest St, Sacramento

On January 18, 2024 Adult Field officers from the High Risk Probation Unit conducted a probation search at the home of an individual under supervision. During the search, officers seized 4 firearms and approximately 833 rounds of live ammunition. Subsequently, the individual was arrested and booked into the Sacramento County Jail on firearms related charges as well as child endangerment.





DISTRICT 2

January 20, 2024 DUI/OTS Compliance Sweep 2200 Block of 16th Avenue, Sacramento

On January 20, 2024, Adult Field officers participated in a county compliance sweep which is part of a federally funded grant that was awarded to the Sacramento County Probation Department from the Office of Traffic Safety. The purpose of the compliance sweep is to ensure individuals that have been convicted of a DUI are in compliance with the terms and conditions of their probation. During the sweep, a probation search of an individual under supervision revealed approximately 3.9 ounces of Cocaine, 14-Oxycotin pills, \$13,800.00 in US currency and one digital scale. All items were seized, and the individual was arrested and booked at the Sacramento County Jail relative to narcotics related charges and a Violation of Probation.



January 23, 2024 Investigation & Supervision Unit 5900 Block of Clover Manor Drive, Sacramento

A records check of an individual under supervision, who is prohibited from owning or possessing any firearms or ammunition relative to Proposition 63, revealed he had several firearms still registered to him. On January 23, 2024, Adult Field officers from the Investigation and Supervision Unit made contact with the individual who peacefully surrendered ten firearms.

DISTRICT 3

January 11, 2024 Investigation & Supervision Unit 5800 Block of Fair Oaks Blvd, Sacramento

A records check of an individual under supervision who is prohibited from owning or possessing any firearms relative to Proposition 63, revealed he had two firearms registered to him. He indicated the firearms were located at a relative's residence. On January 11, 2024, officers from the Investigation and Supervision Unit contacted the relative who relinquished the two outstanding firearms.



DISTRICT 4

January 4, 2024 Investigation & Supervision Unit 5600 Block of Canary Dr, North Highlands

A records check of an individual under supervision who is prohibited from owning or possessing any firearms relative to Proposition 63, revealed he had a firearm registered to him. Officers contacted the individual who indicated the firearm was at a relative's residence, but he admitted to having ammunition. On January 4, 2024, officers from the Investigation and Supervision Unit conducted a probation search at the individual's residence. They seized approximately 6,806 rounds of various caliber ammunition, seven rifle/pistol magazines, various firearm parts, and a replica MP-40 submachine gun. Officers contacted the individual's relative who surrendered the outstanding firearm, three rifles and a pump action shotgun. The individual was arrested and booked into the Sacramento County Jail for Felon in Possession of Ammunition and a Violation of Probation.



DISTRICT 5

January 3, 2024 Rancho Cordova Probation Partnership 3600 Block of Data Drive, Rancho Cordova

On January 3, 2024, officers from the Rancho Cordova Probation Partnership received information that an individual under supervision was involved in a vehicle pursuit that was called off due to excessive speeds. Officers subsequently contacted the individual at his residence and conducted a probation search of his home and vehicle. They seized one loaded handgun and one live 40 caliber round. The individual was arrested and booked into the Sacramento County Jail for Evading a Peace Officer and firearms related charges.

DISTRICT 5 (CONT'D)

January 11, 2024 Juvenile Field-Community Based Supervision 5700 Block of Deepdale Way, Elk Grove

On January 11, 2024, Juvenile Field officers conducted a home visit of a juvenile under supervision. Upon arrival, officers discovered another youth hiding at the home. Both juveniles had a non-association order with each other. During a probation search, officers seized a Polymer80 ghost gun located where one youth was hiding, and a loaded Glock 19 pistol in the other youth's bedroom along with marijuana and suspected counterfeit money. Both individuals were arrested and booked into the Youth Detention Facility on firearms related charges.

January 11, 2024

Investigation & Supervision Unit and Rancho Cordova Probation Partnership 3000 Block of Laurelhurst Drive, Rancho Cordova

On January 31, 2024, probation officers from the Investigation and Supervision Unit and Rancho Cordova Probation Partnership collaborated with the Rancho Cordova Police Department POP team to conduct a probation sweep in the Rancho Cordova area. During a probation search at the home of an individual under supervision, officers located an unloaded revolver. The individual was arrested and booked into the Sacramento County Jail for Felon in Possession of a Firearm as well as a Violation of Probation.
