Multi-Jurisdiction Collaboration

California Office of Traffic Safety Meeting

On February 28, the Sacramento Police Department hosted the California Office of Traffic Safety (OTS) meeting together with other regional law enforcement partners, including Probation, to discuss traffic trends, share information and resources, and provide updates. These quarterly meetings allow agencies to discuss best practices for combatting sideshow activity and impaired driving, among other topics, to keep the community safe on the roadways.





North Adult Day Reporting Center (ADRC) Graduation

On February 21, our North Adult Day Reporting Center (ADRC) including family, friends and staff celebrated the graduation of nine clients. The ADRC program offers clients cognitive behavioral treatment interventions, substance misuse treatment, self-help courses, educational programming, connection to housing, and vocational assistance. Clients also receive family support services, participate in pro-social activities, and pay victim restitution through the Community Outreach Program.

Recovery Court Graduate

On February 14, the Adult Community Correction's Collaborative Court Unit celebrated a client who graduated from Recovery Court. The Recovery Court program includes daily classes, attending urinalvsis testina. three outside support group meetings per week, and participation in pro-social events. The client's probation officer and case manager provided him with the necessary tools to be successful in the community. As a result, he was able to complete the 12-month program in 11 months. Additionally, all of his fines and fees were dismissed, and his probation status was terminated. This client successfully completed the program due to perseverance and hard work.



Veteran's Treatment Court (VTC) program

Michael M. is currently in phase three of the Veteran's Treatment Court (VTC) program. This program is a four phase comprehensive treatment and rehabilitation program through Veteran's Affairs (VA) and monitored by Probation. Michael recently obtained housing through the VA; however, he did not have any furniture aside from a bed. Probation worked with the Assistance League of Sacramento (ALS) to provide him with a new table and chairs. He was very appreciative of the generous donation.





Keeping Our Community Safe

DISTRICT 1

February 1, 2024 *Investigation & Supervision Unit* 1300 Block of El Camino Avenue, Sacramento

Adult Field officers suspected an individual under supervision was involved with drug trafficking and conducted an investigation over the course of 5 months. Subsequently, a search warrant was served on the individual's residence with the help of Sacramento Sheriff's Office Special Enforcement Detail (SED) and probation's K-9 officer, Ace. During the search, officers located a loaded semi-automatic pistol, an unloaded semiautomatic pistol, a loaded extended firearm magazine, an empty firearm magazine, multiple functioning scales. narcotic packaging, approximately 231 grams of methamphetamine and approximately 10.7 grams of cocaine. The individual was arrested and booked into the Sacramento County Jail on drug and firearms related charges.



DISTRICT 3

February 14, 2024 Investigation & Supervision Unit 2100 Block of Eric Road, Carmichael

Adult Field officers received information an individual under supervision was in possession of firearms and involved with narcotic sales. Subsequently, probation authored search warrants for two locations. With the assistance of the Sacramento Sheriff's Office, and Probation's K-9 Ace, the warrants were executed. K-9 Ace helped officers locate the following items at the first 293.7 location: approximately grams of methamphetamine, approximately 1.9 grams of suspected Di-methyltryptamine, a stolen loaded semi-automatic pistol, a .45 caliber firearm magazine containing 10 live rounds, multiple functioning scales and narcotic packaging. K-9 Ace helped officers locate the following items at the second location: a .30-06 caliber bolt action rifle, approximately 377 rounds of various caliber ammunition, an empty magazine and narcotic packaging. The individual was arrested and booked into the Sacramento County Jail on firearms and narcotics related charges as well as possession of stolen property.

DISTRICT 4

February 2, 2024 *Investigation & Supervision Unit* 1200 Block of Creekside Dr, Folsom

A records check of an individual under supervision who is prohibited from owning or possessing any firearms relative to Proposition 63, revealed he had two firearms registered to him. On February 1, officers from the Investigation and Supervision Unit contacted the individual who voluntarily relinquished the two outstanding firearms.



February 13, 2024

Investigation & Supervision Unit 6400 Block of Channing Dr, North Highlands

A records check of an individual under supervision who is prohibited from owning or possessing any firearms relative to Proposition 63, revealed he had four firearms registered to him. On February 14, officers from the Investigation and Supervision Unit conducted a probation search of the individual's residence after he did not voluntarily surrender the weapons. During the search, officers seized three AR-15 style lower receivers, a 9mm semi-automatic handgun, three revolvers (one which was reported approximately 200 rounds stolen), of as ammunition in various calibers, two AR-15 style box magazines, and a single stack 1911 style Additionally, another individual was magazine. located in the home and a records check revealed no bail warrant. he had an outstanding Subsequently, both individuals were booked into the Sacramento County Jail.
