#### **MADD Award**

Sacramento County Probation Department was awarded the 2024 Outstanding Probation Agency Award by Mothers Against Drunk Driving Sacramento. Sr. Deputy Probation Officer M. Lopez and Supervising Probation Officer C. Hernandez were commended for their communication skills and good judgement for successfully deescalating a situation involving a client who was experiencing a mental health crisis. On July 16, the Probation Department and the officers from the Driving Under the Influence (DUI) Unit were given the prestigious award. This unit is supported by grant funds from the Office of Traffic Safety. The officers in this unit



provide intense supervision for clients with felony DUI convictions or multiple DUI convictions. They provide community supervision, conduct probation searches, help with DUI check points, and administer random alcohol and drug tests to ensure compliance with conditions of probation. They are committed to keeping the community safe from drunk and impaired drivers.



#### **Chris Carlson Big Heart Award**

Supervising Probation Officer C. Flewellyn and Senior Deputy Probation Officer K. Cadena have been selected as recipients of the inaugural Chris Carlson Big Heart Award. This award recognizes extraordinary members of the collaborative justice/ treatment court teams. The ceremony was held at the Gordon D. Schaber Courthouse on July 19, 2024.

#### **SOAR Alumni Achievements**

# Keeping Our Community Safe

#### **DISTRICT 1**

#### July 1, 2024

Investigation & Supervision Unit 4200 Block of 20th Avenue, Sacramento

On July 1, 2024, probation officers conducted a search at the home of two individuals under supervision. They located a short-barreled assault rifle containing live rounds of ammunition. The two individuals under supervision were transported and booked into the Sacramento County Jail for violating their parole.



July 26, 2024
Gang Suppression

On July 26, 2024, a probation officer observed a live social media feed of 5 individuals with assault weapons driving in a rival gang neighborhood. The officer immediately notified the Gang Investigators with Sacramento Police Department and Sacramento Sheriff's Office. Subsequently, SSO officers were able to identify the suspects and the vehicle as being involved in a recent crime. The vehicle was located, the individuals were arrested, and the firearms were seized.



#### July 2, 2024

Investigation & Supervision Unit 8000 Block of Walerga Road, Sacramento

During a probation search of an individual under supervision, officers located a large quantity of Fentanyl pills, cocaine, a digital scale, and narcotic packaging. The individual was arrested and booked into the Sacramento County Jail on narcotics related charges.



July 17, 2024 Community Based Supervision South

3700 Block of East Pacific Ave, Sacramento

During a probation search at the home of two juveniles under supervision, officers located a semi-automatic handgun with a magazine containing multiple live rounds of ammunition. Both juveniles were transported and booked into the Youth Detention Facility on firearms related charges.





# **Keeping Our Community Safe**

#### **DISTRICT 5**

July 16, 2024
Investigation & Supervision Unit
2400 Block of Glenfaire Drive, Rancho
Cordova

On July 16, 2024, a residential search warrant was served at a home where two individuals resided, one of whom was an individual under supervision. During the search, a short-barreled rifle and four rounds of ammunition were found. After a records check, it was revealed that there was also a fugitive arrest warrant out of the state of Oregon for the individual not under supervision. Both individuals were subsequently arrested and booked into the Sacramento County Jail.



July 30, 2024

Community Based Supervision South 5700 Block of Deepdale Way, Elk Grove

On July 30, 2024, officers conducted a probation search at the home of a juvenile under supervision. Another juvenile under supervision was also located in the home. During a search, officers located live rounds of ammunition on the kitchen table and a semi-automatic handgun with a magazine containing multiple rounds of ammunition in the juvenile's bedroom. Both individuals were transported and booked into the Youth Detention Facility.

#### **LEAP All-Star Basketball Game**

Youth Advocate Bill Collins and the Leadership Enrichment Achievement Program (LEAP) organized an All-Star basketball game in the gym. Residents were selected from a variety of units within the Youth Detention Facility to form two teams of seven. The game was composed of four, 10-minute quarters. Juvenile Court's Presiding Judge Tedmon and Judge Dhillon came out to support the teams as they battled to gain the title of All-Star Champions!

After the game was over, Judge Tedmon gave the youth in attendance a speech on the importance of the power of dreams, beliefs, and mentoring in the life of incarcerated juveniles. Judge Tedmon, who has been coaching basketball since 1999, ended his speech with a round of basketball drills and game strategy advice. We thank Judge Tedmon and Judge Dhillon for taking time out of their busy schedules to attend the game and supporting positive change by being positive role models.
