## FIRST VOYA YOUTH PARTICIPATES IN COMMUNITY OUTREACH

The Sacramento County Probation Department recently created a Youth Community Outreach Unit (YCOU) that will take VOYA youth into the community to work when they are nearing re-entry. This program provides the youth an opportunity to learn new skills as well as earn money that will be available upon their release. The department is collaborating with the County Animal Services, Sacramento City Parks and Recreation, and the Bureau of Land Management and others to support this effort. The youth are accompanied by probation officers from the YCOU unit on various day to different work sites. In November, the first two VOYA vouth worked at the Bradshaw Animal Shelter. Their job duties include cleaning kennels, washing and folding laundry, organizing, and feeding the animals. VOYA Youth also worked at the Consumnes River Preserve maintaining the landscape.





### Multi-Jurisdiction Collaboration



#### Sacramento County Probation Department Awarded Grant from the Office of Traffic Safety

Sacramento, Calif. – The Sacramento County Probation Department received funds for an intensive probation supervision program for high-risk DUI offenders with multiple DUI convictions.

The \$610,000 grant from the California Office of Traffic Safety (OTS) will go toward the monitoring, supervision, and support of individuals on probation for a DUI offense to ensure they are following court -ordered terms of their probation and prevent probationers from re-offending.

"The OTS grant will make it possible for our officers to maintain close supervision of DUI offenders and ensure they stay in compliance with their probation conditions in an effort to reduce the number of repeat DUI offenses and collisions," said Chief Probation Officer Marlon Yarber.

"The intensive supervision programs are critical to reducing the devastating consequences of DUI offenses," OTS Director Barbara Rooney said. "Prevention is an effective, proactive tool to address the often tragic consequences of impaired driving."

The probation grant will also fund warrant operations targeting probation violations and/or DUI suspects who do not appear in court, alcohol testing, officer training in Standard Field Sobriety Testing (SFST) and collaborating with courts and prosecutors to establish probation orders.

The grant program runs through September 2024.

Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.

# Sacramento County Probation Department's DUI Court sets people on a life-changing course

"In the past, the direction that was taken was more focused on a punitive mindset, but with our new approach, we are still holding people accountable, but we are also trying to set them up for success through rehabilitation and assistance through our resources and community partners," says Nicole De La Riva, Deputy Probation Officer with the DUI Court. "There are rules to follow that we hold probationers accountable for, but incarceration is not the only thing we do. We have our own programs and plenty of other resources to help meet our probationers' needs. I think that many people we supervise can be misguided if the only thing we do is implement punishment by incarceration. We know that our job is to put them back in jail for violating their probation restrictions, but we also do so much more outreach and follow through with helping them. What we actually do is evaluate alternatives to incarceration and use jail only as a last resort."


#### SPO Maria Rivera-Collins and Sr DPO Consuelo Palafox-Chavez

#### North Adult Day Reporting Center (ADRC) Graduation

## **Celebrating Success**

#### Holiday STAR (Student Talent Achievement Reward) Program

The Holiday STAR (Student Talent Achievement Reward) program is designed to recognize and reward preschool and elementary school students in the city who, despite facing challenging financial circumstances, have worked hard to become high achievers both academically and behaviorally. Rancho Cordova city employees take part in supporting these students who have overcome so much in spreading holiday goodwill to these students and their families! Those involved include City Council and staff, Metro Fire, Rancho Cordova Police Department, Probation, Neighborhood Services, and other volunteers. Each student is individually recognized by a school administrator and then paired up with city employees. The city employees assist the students and their families in redeeming a \$100 gift card at Target for Christmas shopping.







#### **ADRC and Relgnite Welding Success**

As part of the Adult Day Reporting Centers (ADRC), Leaders in Community Alternatives (LCA) recently started a collaboration with **Relgnite Hope Welding Program.** The program has a Mobile Welding Training Center that is brought into Sacramento, CA four times a year and is fully operated by volunteer trainers and donated equipment. Through the ADRC program, participants are provided with work boots, attire, gas cards or bus passes to ensure they are set up for success before and during the program. With completion of the program, clients are eligible to test and receive two American Welding Certifications.

One recent success is a client, who graduated from ADRC-North in November. He further completed the Relgnite Welding Program, earning two American Welding Certifications. Simeon is on track to be employed and was one of the top students in the latest Relgnite Welding class. He completed the training program with 100% attendance and has an opportunity to volunteer with the Training Program.

## Keeping Our Community Safe

#### **DISTRICT 1**

November 29, 2023 High Risk Probation

On November 29, 2023, officers conducted a probation search at the residence of an individual under supervision. During the search, officers seized 12 firearms, over 1000 rounds of live ammunition, approximately 49.9 grams of psilocybin mushrooms, and approximately 20.6 grams of Xanax pills. Subsequently, the individual was arrested on firearms and narcotics related charges and booked into the Sacramento County Main Jail.

On November 29, 2023, officers conducted a home compliance check of an individual under supervision. As officers approached the residence, the individual attempted to leave the residence in a vehicle. Officers detained the individual and conducted a probation search of his vehicle and his person. Officers located a loaded revolver in his vehicle and suspected narcotics on his person. The individual was arrested and booked into the Sacramento County Mail Jail.

As a part of the program, they create a resume, interview, and have quarterly job performance reviews.


## Youth Detention Facility (YDF) News
