
You helped him become a better person. I want your department to know what an asset they have. You are the best. With my most sincere and utmost respect and gratitude, Thank You."



Guns, Drugs, and Cash Confiscated in North Sacramento Gang Sweep

On March 10, 2022, probation officers assigned to the Adult Field Suppression Unit and the Juvenile Field Age of Majority Unit organized an after-hours gang sweep with K9 Officer Hope and the Sheriff's Gang Task Force in North Sacramento. Officers submitted reports to the District Attorney's Office for prosecution. Results of the Sweep:

Sex Offender Compliance Sweep Results in Violations, Arrests, and New Charges in Northwest Sacramento

On March 29, 2022, probation officers assigned to the <u>Sacramento SAFE Team Task Force</u> conducted a Compliance Sweep on registered sex offenders living in the Northwest Sacramento area. The focus of the operation was to make contact with adults on probation and parole assigned to a sex offender caseload and to ensure compliance with their terms and conditions of probation as well as their requirement to register pursuant to Penal Code 290. Officers conducted 14 searches resulting in several violations, arrests, seized electronic devices, and new charges.



DISTRICT 1

March 3, 2022 3300 Block of Smoketree Drive, Sacramento

Probation officers received information that a youth was in possession of a gun. Juvenile Field officers performed a search of the youth's person and residence and discovered a firearm along with a small amount of marijuana in the youth's room.



DISTRICT 2

March 15, 2022

7800 Block of Dalewoods Way, Sacramento

Probation officers served a search warrant at a residence in South Sacramento connected to an adult on probation.

With the assistance of the Sacramento Sherriff's Gang Unit and Special Enforcement Detail, officers located a loaded Glock style ghost gun with a 30 round magazine, ammunition, and cocaine. Two individuals were arrested on various charges and violations.





DISTRICT 3

March 8, 2022 Carmichael

Officers assigned to The Adult Day Reporting Center (ADRC) Central arrested an adult on charges associated with Willful Disobedience of a Court Order.

DISTRICT 4

March 8, 2022

7500 Block of Community Drive, Citrus Heights

Probation officers assigned to the ADRC Central arrested an adult on a no-bail warrant who was residing in a vacant house.

The individual was transported to jail without incident with the assistance of the Sacramento Sheriff's Office.

March 21, 2022

8000 Block of Twin Oaks Avenue, Citrus Heights

An officer assigned to the ADRC Central coordinated a vehicle stop with the Citrus Heights Police Department of an adult with outstanding felony warrants.

The individual was arrested for Possession of Firearm by a Felon; Unlawful Possession of a Controlled Substance; Evading a Police Officer/Driving in a Reckless Manner; Theft and Unlawful Driving or Taking of a Vehicle; and Evading a Peace Officer/Driving Opposite Flow of Lawful Traffic.


March Competitions Created New Champions













Assistant Probation Officer Jackson Named Coach of the Year







All youth participated in a weeklong Ninja Warrior course designed by a probation officer. Staff timed the competitors, and the winner was named Champion Ninja Warrior.



Nine youth participated in the El Centro High School graduation ceremony. They wore caps and gowns and walked to Pomp and Circumstance. A youth played piano for the event, Principal Barbara Modlin gave an address, and each graduate spoke. Attendees included family and peers, as well as school and probation staff.

Anti-Recidivism Coalition Founder Talked with Future Firefighters

Anti-Recidivism Coalition (ARC) Founder Scott Budnick toured the facility and discussed Fire Camp with Valley Oak Youth Academy youth.

From the ARC brochure:

In partnership with <u>CAL FIRE</u>, <u>California Conservation Corps</u>, and <u>California Department of Corrections and Rehabilitation</u>, ARC opened the Venture Training Center (VTC) in 2018, providing participants who are on parole training for careers as firefighters after program completion. This innovative program provides advanced firefighter training, certifications, and job readiness support to create a pathway for former offenders to compete for entry-level firefighting jobs with state, federal and local agencies.

Founded in Los Angeles in 2013, ARC serves more than 1,600 formerly incarcerated people across California. The majority of members live in LA County. In September 2016, ARC opened a second office in Sacramento, serving 1,600 members with case management and counseling services.





NCCT HIGHLIGHTS

In March, Northern California Construction Training (NCCT) provided youth with concrete experiences in the construction field.







Laborers Agility Test Competition

Youth enrolled in NCCT have firsthand experience in how truly laborious construction is during Laborers Agility competition. This test consists of shoveling and wheel barrowing gravel, moving cement cylinder blocks from one pallet to another and moving and stacking wood planks from one end of the courtyard to the other. All three obstacles are timed, and youth with the top eight scores are recognized and rewarded for their hard work.

Home Construction Skills Training

NCCT students worked with framing components, installing pre-hung doors, and nailing schedules.


