

Keeping Our Community Safe

DISTRICT 1 FIREARMS, AMMUNITION & DRUGS SEIZED & A FELON ARRESTED

December 8, 2022

2400 Block of Fairfield Street, Sacramento Probation Officers with the Investigations & Supervision Unit (ISU) conducted a probation search of the residence of two adults on formal searchable probation. One individual had multiple outstanding warrants. During a search of the residence, officers located a Glock firearm, a magazine with 9 rounds of ammunition, methamphetamine, a scale, and personal identification information belonging to other individuals.

The case has been forwarded to the District Attorney for Possession of a Firearm by a Felon; Possession of Controlled Substances for Sale; and Possession of Ammunition by Prohibited Person.



DISTRICT 2 PISTOLS, AMMUNITION & DRUGS SEIZED & ARRESTS MADE

November 29,2022 7500 Block of Brownwood Way

Officers with the Gang Suppression Unit (GSU) conducted a probation search of an adult and recovered a revolver style pistol with live rounds chambered and additional ammunition. Officers also located identification belonging to a second individual. A records check revealed the second individual was a convicted felon prohibited from owning or possessing firearms. The second individual arrived at the residence and immediately fled in a vehicle. Officers seized the firearm and ammunition and booked it as evidence pending investigation.



November 29, 2022

7400 Block of 21st Street, Sacramento During a compliance check of an adult under supervision, officers with the Gang Suppression Unit (GSU) located a second individual in the bedroom. The second individual spontaneously stated she had a firearm in her cross body bag. For officer safety, officers searched the bag and located a Glock 19 Semi-Automatic gun with live rounds in the magazine.

Upon searching the room, officers also located heroin and crystal methamphetamine. The second individual admitted ownership of the firearm and narcotics and was arrested for Possession of Illegal Weapon; Possession of Controlled Substances While Armed; Possession of a Controlled Substance; and Possession of Methamphetamine.



December 21, 2022

6900 Block of Wagon Wheel Way, Sacramento During a search of the car and residence of an adult under supervision, officers with the Electronic Monitoring Home Supervision (EMHS) unit located Ecstasy pills, methamphetamine, a stolen loaded Glock 17, a 9mm high capacity magazine, a magazine loaded with 40 caliber ammunition, and a box of 9mm ammunition. The individual is pending charges of Carrying a Loaded Firearm in a Vehicle, Carrying a Concealed Weapon, and Possession of a Firearm by a Prohibited Person.



DISTRICT 3 RIFLES, AMMUNITION & DRUGS SEIZED, DRUG SALES THWARTED, & FELONS ARRESTED

6900 Block of Hurley Way, Sacramento December 14, 2022

While conducting a home visit of an adult individual on Mandatory Supervision, Probation officers with Investigations & Supervision Unit (ISU) located a gun safe in the bedroom belonging to the individual. Officers opened the safe with the assistance of Sacramento Metro Fire, and located fentanyl, methamphetamine, heroin, and over \$5,000 cash. Officers also located messages on the individual's cell phone consistent with narcotic sales. The individual was booked for Possession of Controlled Sale: Possession Substances for of Methamphetamines for Sale: and Committing a Felony While on Bail.



8900 Block of Sutter's Gold Drive, Sacramento December 22, 2022

Probation officers with Investigations & Supervision Unit (ISU) conducted a search of an individual on Formal Searchable Probation. During the search, they recovered a shotgun, firearm, 2 rifles and numerous boxes containing various calibers of live ammunition, some of which were unsecured in a child's bedroom. The individual was arrested for Criminal Storage of a Firearm; Endangering the Life or Health of a Child; Carrying Concealed Firearm in Vehicle: Prohibited Person Owning/ Possessing Ammunition/Firearm: Felon in Possession of Firearm; Felon in Possession of Ammunition and Firearm by a Prohibited Person.



3400 Block of Huss Avenue, Sacramento December 15, 2022


After receiving a tip that an adult on formal searchable probation was involved in narcotic sales and possibly possessed a firearm, officers with the Investigations & Supervision Unit (ISU) detained the individual during a scheduled office visit.

During a subsequent search of the individual's vehicle and residence, ISU officers located the following:

- Ecstasy pills
- Methamphetamine
- Reported stolen Glock 17, loaded
- A high capacity magazine with 31 rounds
- 54 additional rounds

The individual was arrested for Felon in

Possession of a Firearm; Felon in Possession of Ammunition; and a Violation of Probation.
