Sacramento County PROBATION

Weekly Activity Log

The following information listed in the Weekly Activity Log provides a snapshot of significant actions by Probation Officers in the community of Sacramento. The events reported are preliminary actions, taken in the field by Probation Officers, and may or may not be referred for further investigation. Certain details of these incidents have been removed due to potential follow up investigation and/or for privacy rights.

Week of June 24, 2019 to June 28, 2019:

JUNE 26, 2019 (POSSESSION OF NARCOTICS FOR SALES) - DISTRICT 5

Officers from the Rancho Cordova Probation Partnership and Gang Unit, assisted by Rancho Cordova Police Department's P.O.P. Team conducted a home visit of a known probationer currently on Post Release Community Supervision. During a search of his residence, officers found Heroin, Methamphetamine, illegal prescription pills, 4 digital scales, illegal fireworks, and over \$2,000.00 dollars in cash. The subject was arrested for Possession of Controlled Substance for Sales, Possession of Methamphetamine, Possession of a Controlled Substance, Possession of Narcotic Paraphernalia, and Possession without Permit of



Dangerous Fireworks. The subject was transported and booked at the Sacramento Main Jail.

JUNE 26, 2019 AND JUNE 27, 2019 (PROBATION SWEEP) - DISTRICT 5

Officers from the Probation Department and the Rancho Cordova Police Department's P.O.P. Team conducted a two-day probation sweep in the City of Rancho Cordova. The purpose of this operation was to work collaboratively and to conduct probation searches to verify compliance with the terms and conditions of probation in an effort to reduce criminal activity during the extended 4th of July weekend. Additionally, the operation involved collective efforts from Rancho Cordova Animal Services and Code Enforcement Units. As a result of the operation, officers generated the following statistics:

JUNE 27, 2019 (MINOR IN POSSESSION OF A FIREARM) - DISTRICT 1

Officers from the General Supervision Unit conducted an address verification of a probationer pending transfer from another County to Sacramento County for supervision. During the course of their investigation, officers contacted several juveniles on probation inside the residence and one parolee. A search of one of the juveniles who was on probation resulted in finding a loaded, stolen .38 revolver which fell out of his waistband. A subsequent search of the residence produced 42 additional live .38 special ammunition rounds and a holster. The juvenile was arrested for Minor in



Possession of a Firearm, Minor in Possession of Ammunition, Altering Serial Number of a Firearm, and Carrying a Concealed Stolen Firearm. The juvenile was transported and booked at the Youth Detention Facility.
