| The Chair provided an update on Probation's approved budget, a new mental health unit will be added to <br> the adult services side of probation, Pre-Trial will obtain additional positions, and there will be Juvenile <br> Community Outreach Re-Entry positions, including one supervising probation officer, one senior deputy <br> probation officer and two deputy probation officers. The goal would be for VOYA youth to participate in <br> outside work experience with the Parks and Recreation department under officer supervision. The fourth <br> unit that was requested for VOYA was not granted at this time. The new mental health unit will assist in a <br> decrease of the population in the Main Jail. <br> The Chair stated Ending Girls Incarceration grant will provide technical assistance of $\$ 125,000$. The <br> Probation Department is looking to send out a determination of interest to the community to see what <br> services can be provided to girls currently in custody and to help prevent future girls from entering custody. <br> On subsequent years, the Office of Youth Community Restoration is providing community-based <br> organizations $\$ 200,000-\$ 250,000$ to continue with initial efforts. <br> The Chair notified the subcommittee a county counsel representative will appear in the August meeting to <br> address their concerns regarding the community members having alternates. |  |

3. VOYA Realignment Update

Kristy Dyson, Heather Horton, and Laticia Crump from Valley Oak Youth Academy (VOYA) inside the youth Detention Facility (YDF) provided the committee with an overview of what VOYA is and what they do.
VOYA's program services include education and career technical training, mental health crisis intervention, medical health, therapeutic services, life skills/job training, pro-social enrichment activities, and re-entry. The program components are as follows:

- Individualized Rehabilitation Plan (IRP)
- 6 Month VOYA Progress Review hearings - opportunity for baseline reduction
- Victim Empathy Course
- Stanford Sierra Youth and Family
- ProjectME: Life Skills and Job Training Program
- VOYA Employment Program
- "Who's This, What's That?": A Multi-Cultural Journey
- Juvenile Sex Behavior Treatment Model
- Step-Down Opportunities

The VOYA program inside YDF provides a safe and secure environment for realigned youth serving commitments after the closure of the Division of Juvenile Justice (DJJ). Within 30 days of entering VOYA, a rehabilitation plan is created and every six months a court hearing is held for a possible baseline reduction of up to 6 months. They have career technical training such as culinary and construction to attend while they are inside YDF. The youth have expressed interest in having more types of career technical training, such as welding. There is also a step-down option based on requirements for the youth called Pine Grove Fire Academy. Member Gray inquired about what those requirements are. Supervising Probation Officer Dyson listed off some of the requirements: must be 18 years or older, certain offenses are not permitted, youth must have a high school diploma or GED, and there must not be any less than 6 months and no more than 2 years left on their term. The Sacramento County Office of Education provides three educational pathways for the youth, they can obtain their high school diploma, HISET, and an AA degree. There is also the option to obtain an AA degree with the ability to transfer to a university. Supervising Probation Officer Dyson explained in VOYA they try to treat them more as adults, so, they use a level system, and everyone has the same bedtime.
Member Ibarra questioned if the youth upon release will be assigned to Probation or the Re-Entry Support Coordinator through SCOE. The Chair explained that they will be assigned to both, because they must be under Probation supervision for a certain period of time.

Molly Howard and Elise
Sampson, Stanford Sierra Youth \& Families'
Elise Sampson and Molly Howard from Stanford Youth Solutions provided an update on the services they provide. Elise stated they traditionally serve youth in the field, after an assessment and referral from their probation officer. Elise also stated that while a youth is in VOYA, they are required to participate in counseling. For the VOYA youth, they set concrete objectives and goals for their counseling and treatment progress reports are sent to Probation. Stanford Youth takes a collaborative approach to their counseling, they try to involve the family more and they have an after-care process. Molly Howard mentioned they have comprehensive assessments to determine needs for treatment based off trauma, family, safety, etc. Each treatment plan is individualized to the youth. There are plans for re-entry for VOYA, coping management, and substance abuse. Both Molly and Elise expressed their team is trying to problem solve around visiting the youth inside the Youth Detention Facility based off the staffing issue Probation is currently having.

Member Patterson asked if they could take the youth to the sensory room if the youth requested it. She spoke with some of the youth, and they expressed interest in going to the sensory room.

Chief Deputy Probation Officer Brandi Curry ensured that the youth's custody time is being considered and none have completed their baselines. She also stated the original baseline in not being reimposed and the DJJ time is being considered as well.
