- You shall submit to a limited background investigation, which includes, but is not limited to, fingerprinting and a criminal history check. Failure to complete or pass the background investigation automatically disqualifies an applicant from the program.
- You agree to complete a minimum of twenty (20) hours of service per month. Applicants should be aware that their college/university may require more or less hours as a class requirement, however, twenty (20) hours are the minimum requirement for participation in this program. (Upon admission to the program each student intern and the unit supervisor to whom they are assigned, will determine scheduling).
- Sacramento County Probation Department issued identification cards shall only be used as required in the performance of official Student Intern Program duties. Misuse of the identification card may result in termination. Upon program termination, you shall surrender your identification card to the Sacramento Probation Department.
- Sacramento County Probation Department reserves the right to refuse or terminate any student intern's program "At Will", without cause and without right of appeal.
- Applicants should include any special skills or abilities that they possess which could enhance their experience in the program. Additionally, applicants will be given the opportunity to designate areas of preference for their internship; however, assignments will be based on need, skills and availability.
