Probation Officers Duran, J. and Krehbiel, A. Shine During Retail Theft Blitz

On January 7, 2025, during a high-intensity retail theft operation put on by Rancho Cordova Police Department (RCPD), Crime Suppression Unit, Probation Officers Duran and Krehbiel played a crucial role in the operation's success. Their dedication, quick response, and commitment to teamwork were vital in ensuring the operation ran smoothly and efficiently.

The operation resulted in 11 felony arrests under the new Proposition 36 laws, as well as 4 misdemeanor citations. In total, over \$5,700 worth of stolen merchandise was recovered.

While the operation involved many moving parts, Officers Duran and Krehbiel stepped up when the team was stretched thin. They were consistently the first on scene, quickly assisting with detaining arrestees at four different stores in the plaza. They helped with transporting individuals, to the booking room, and played a key role in identifying violations and assisting with initial investigative steps.

RCPD Sergeant Travis A. shared in his recognition of the officers, "Their presence was felt throughout the operation, they were always ready and available to help, no matter what the task. Their professionalism and teamwork are a reflection of their strong commitment to public safety."

This partnership and their unwavering support have made a significant impact, as they continue to represent the Sacramento County Probation Department with excellence.

Thank you, Officers Duran and Krehbiel, for going above and beyond in service to the community.





Celebrating Success

First Adoption of a Foster Youth Under the Probation System

In September of 2024, Sacramento County marked a historic achievement with the first-ever adoption of a foster youth under Probation supervision.

The youth was initially placed in a Short-Term Residential Therapeutic Program (STRTP) in 2019. During the two years in their care they identified he did not have family members who could provide the necessary support as he prepared to transition from STRTP.



In response, Probation began working to establish a Resource Family (RFA) home. In June 2023, the youth was placed with a family that has since offered a stable and nurturing environment. The transition has proven to be incredibly positive for him; he has thrived in his new home.

Looking ahead, the youth has set his sights on becoming an EMT and joining the Military, demonstrating his commitment to a bright future.

A Juvenile Probation Success Story

In March of 2023, a youth on Juvenile Probation faced significant challenges and was placed in a Short Term Residential Therapeutic Program (STRTP) to receive the guidance and structure needed to succeed. Over the following 16 months, with unwavering dedication from DPO Boughton and STRTP staff, this young person demonstrated incredible resilience and turned his life around.

In November 2024, his hard work paid off when he graduated from high school. He then earned the opportunity to further his education by being accepted into Sacramento State University.

DPO Boughton played a critical role in supporting this youth's transition into the AB-12 Transitional Housing Program, providing him with stable housing near the Sacramento State campus. This transition ensured he had the resources and stability needed to succeed as a full-time student.

On December 13, 2024, he was terminated from Probation, marking a significant milestone in his journey toward independence.

We celebrate this youth's accomplishments and DPO Boughton's assistance.

Overcoming Adversity

On April 14, 2024, a client under probation supervision was released from prison and faced immediate struggles with housing and substance abuse. On May 15, 2024, DPO Calhoun successfully contacted the client, who was unhoused and sleeping outdoors. Recognizing the need for support, DPO Calhoun referred him to the Stockton Salvation Army Adult Rehabilitation Program.

On May 22, 2024, the client was accepted into the program. Through dedication and hard work, he successfully graduated on December 11, 2024. After completing the program, he was discharged from Post Release Community Supervision (PRCS) and is now employed with Salvation Army Hope Harbor, contributing to the culinary services program.

This story highlights the impact of proactive probation supervision and the crucial role of programs like the Salvation Army in helping individuals turn their lives around.




Officers & Programs Making a Positive Impact

On January 4, 2025, officers from the DUI/OTS Unit conducted a probation compliance check at the residence of a probationer on formal searchable probation. During a search of the property, officers discovered a black firearm and a loaded 15-round high-capacity magazine. The probationer was arrested for violations of Penal Code Sections 29800 and 30305 and booked into Yolo County Jail. The crime report was submitted to the Yolo District Attorney's Office for further action.

Culinary Arts Program

In the month of January, residents had the opportunity to make chicken and waffles. Mr. Doolittle instructed the class on how to make batter to deep fry chicken by utilizing flour, battered eggs and panko seasoning. Afterwards, the residents had the opportunity to demonstrate how to properly cook the chicken in the deep fryer while monitoring the temperature. The residents also learned how to make waffles by mixing pancake mix and milk together and utilizing the waffle maker.



In another session, Mr. Doolittle offered the residents a variety of meats, pastas and vegetables and allowed them the opportunity to make any dish with the food provided. The residents made baked potatoes, shrimp and pasta, pork chops with a side of vegetable's, steak mixed with rice and chorizo with eggs. For dessert, residents had ice cream with a variety of toppings to choose from.

Northern California Construction Training (NCCT)

During the first week of January, the Northern California Construction Training (NCCT) residents participated in the Labor Agility Test. The top eight residents with the lowest times received a luncheon provided by NCCT.

Last week students worked on completing platforms for new metal sheds. In the morning classes, residents began assembling components for skeleton framework on metal structures. In the afternoon classes, residents learned how to read a tape measure and practical math applications in construction. In addition, all residents who are enrolled in the NCCT program participated in the CPR & First Aide class. All 30 residents received their certification for CPR & First Aide training.

Leadership Education and Athletic Program

Certified Physical Training

During the month of January, the Leadership Education Athletic Program focused on personalized physical training. Residents learned how physical training works at a certified level. They were instructed on proper ways to stretch and warm up. Residents also learned proper breathing techniques, isometrics, balance, and stability. The residents expressed their fitness goals and then received organized physical training. They completed the training within the hour allotted and learned the proper way to train their bodies for optimum health.
